# Freedom of Information request: Right to know request

Thank you for your request for information concerning correspondence between Ofcom, Altice and Flint Global. Your request was received on 3 December 2021 and we have considered it under the Freedom of Information Act 2000 (the FOI Act).

### Your request

Please disclose all correspondence between Ofcom and the following regarding the UK's broadband infrastructure since March 2021:

- Patrick Drahi, the founder of Altice
- Any Altice employee or representative of Altice
- Flint Global, the consultancy, including Ed Richards, the co-founder.

## Our response

While I can confirm that we do hold information falling within the scope of your request, we consider that disclosure of this information is exempt under the FOI Act. In particular, section 44(1)(a) of the FOI Act exempts disclosure of information if its disclosure is prohibited by or under any enactment. Section 393 of the Communications Act 2003 (the Act) prohibits the disclosure of information about a particular business (in this case Altice) which has been obtained in exercise of a power conferred by, among other legislation, the Act, so long as that business continues to be carried on, unless we have the consent of that business or one of the statutory gateways under section 393(2) of the Act is met, neither of which applies here. Section 44 of the FOI Act is an absolute exemption and therefore is not subject to a public interest test.

We also consider that other exemptions under the FOI Act would also apply here such as the exemptions under section 41 of the FOI Act (which states that Information is exempt information if it was obtained by the public authority from any other person (including another public authority), and the disclosure of the information to the public (otherwise than under the FOI Act) by the public authority holding it would constitute a breach of confidence actionable by that or any other person) and section 43(2) of the FOI Act (which states that information is exempt information if its disclosure under the FOI Act would, or would be likely to, prejudice the commercial interests of any person).

#### Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter.** There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review.
