## Freedom of Information: Right to know request

Thank you for your request for information asking for the number of contractual home workers at Ofcom. We received this request on 31 August 2022 and have considered it under the Freedom of Information Act 2000.

### Your request

You asked:

This is an information request relating to the number of staff who are contractual home workers.

Please include the following information:

\* The number of staff that currently work employed by the organisation that are contractual home workers

Please also include the following information:

\* The number of contractual home workers employed by the organisation in each of the last three financial years: 2019-20, 2020-21, 2021-22

By "the department" I mean the core department

By "contractual home workers" I mean employees who have it written into their contracts that their normal working arrangements are to work from home.

If it is not possible to provide the information requested due to the information exceeding the cost of compliance limits identified in Section 12, please provide advice and assistance, under the Section 16 obligations of the Act, as to how I can refine my request.

### Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter.** There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you are not content with the outcome of the internal review, you have the right to apply directly to the Information Commissioner for a decision.
