1. 3.7 Studies have shown that the airborne use of a UE can cause quality of service impacts on the host mobile network. To ensure that this potential problem can be managed by the impacted network, the airborne use of any UE is only permitted with the express written permission of the host MNO(s). In the case of a drone operator seeking to use connectivity provided by a Mobile Virtual Network Operator (MVNO)1 written permission must be obtained from the MNO whose physical network is to be used by the device while airborne."

Information requests

If you are unhappy with the response you have received in relation to your request for information and/or consider that your request was refused without a reason valid under the law you may ask for an internal review. If you ask us for an internal review of our decision, it will be subject to an independent review within Ofcom.

The following outcomes are possible:

- the original decision is upheld; or
- the original decision is reversed or modified.

Timing

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you wish to request an internal review, you should contact information.requests@ofcom.org.uk.
