# Freedom of Information request: Right to know request

Thank you for your request for information concerning radio frequencies licensed by Ofcom to UK Search and Rescue . Your request was received on 10 March 2023 and we have considered it under the Freedom of Information Act 2000 (the "FOI Act") and the Environmental Information Regulations 2004 (the "EIR").

can you provide all radiofrequencies license by Ofcom to UK search and rescue (UKSAR)

## Our response

All of the frequencies that we have licensed to the MCA (on behalf of UKSAR) are included in our publication "Frequencies for distress and safety, search and rescue and emergencies in the UK".

It is government policy that the Crown pay for the spectrum that it uses. We therefore issue radio licences to Crown bodies, where the licence fee reflects the value of the spectrum being used (as opposed to reflecting our costs). Of the frequencies listed in this publication, only the UHF frequencies listed for Polycon and the VHF frequencies have actually been licensed, as such, to UK SAR. Other frequencies are not licensed, as such, as the user is a Crown body.

If you wish to exercise your right to an internal review **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review.
