Freedom of Information: Right to know request

Thank you for your follow up requests for information about Ofcom and Nominet and Ofcom and its subject access request ('SAR') process. These were received on 29 June 2023 and we have considered them under the Freedom of Information Act 2000 ('the FOI Act'). Your requests follow an earlier similar request from 13 June 2023 under reference 1632154 and a number of other FOI Act requests along the same subject – see the table below.

Your requests

1. Nominet

'It is highly irregular that the regulator for communications is not maintaining global logging of its communications in a readily filterable format for the purposes of its compliance obligations.

As requested please further narrow this request to the team of senior management during the requested period(s).'

Earlier request from 13 June 2023:

'For all emails exchanged between *@ofcom.org.uk and @nominet.* during the Month of "March 2022" please provide a list containing from: address, to: address, subject: line and if fees permit the name of any files attached to the emails.'

2. Ofcom SAR process

'Please provide all documentation held by Ofcom on what process it follows when searching email logs and email contents to service a Subject Access Request.'

Our response

In response to request 1, we have taken the period of this follow up request to be March 2022, as under reference 1632154.

We hold two documents within scope of the request of an administrative nature, however we consider they are exempt from disclosure under section 44 of the FOI Act. Section 44 exempts the

disclosure of information which is prohibited by another enactment. In this case, we are prohibited under section 393 of the Communications Act 2003 from disclosing information which relates to a business (in this case, Nominet), which we have obtained in exercising our powers, unless we have the consent of that business or one of the statutory gateways for disclosure under section 393(2) is met, neither of which applies here. Section 44 is an absolute exemption and does not require a public interest test.

In response to request 2, this request is of a very wide manner without any obvious purpose. The nature of the process we follow in relation to subject access requests depends on the scope of the specific request concerned. Information requests

If you are unhappy with the response you have received in relation to your request for information and/or consider that your request was refused without a reason valid under the law, you may ask for an internal review. If you ask us for an internal review of our decision, it will be subject to an independent review within Ofcom.

The following outcomes are possible:

- the original decision is upheld; or
- the original decision is reversed or modified.

Timing

If you wish to exercise your right to an internal review, **you should contact us within two months of the date of this letter**. There is no statutory deadline for responding to internal reviews and it will depend upon the complexity of the case. However, we aim to conclude all such reviews within 20 working days, and up to 40 working days in exceptional cases. We will keep you informed of the progress of any such review. If you wish to request an internal review, you should contact information.requests@ofcom.org.uk.
