As the chair of ofcom could I please make you aware of the two outstanding fines against Mark Steyn who until recently broadcast to the public between 8 and 9 pm weeknights on GB news. Despite organised opposition to the 18 month old GB News channel, there has been a growing viewership from those feeling disenfranchised, and who share many of the views expressed by presenters which are less frequently heard on the msm.

Lobby groups have been successful in making it unaffordable, because of the ofcom fines, for GB news to afford to keep Mark Steyn on their channel.

In your position as chair could you please allow a review of the validity of the two fines in a balanced way because I am sure that you are aware of the feeling, amongst viewers, that the bbc has escaped fines for 'bias' which is what appears to be the case against Mark Steyn. I will encourage those who feel, like me, that Mark Steyn has been overly criticised in these circumstances, to also contact YOU because the ofcom online complaints page doesn't appear to cater for complaints against themselves.
