Freedom of Information request: Right to know request

Thank you for your request for information about the ITC's 1998 report into *The Connection*.

We received this request on 21 June 2024 and we have considered your request under the Freedom of Information Act 2000 ("the FOI Act").

Your request

I am trying to track down a copy of the investigation report and would be very keen to know if there are any other related documents in the ITC archive. I am writing to you because I understand that Ofcom holds and maintains the ITC archive. I would be keen to find out how I might be able to access it or speak to the archivist in charge.

The report I am especially keen to see, was I believe, published around December 1998 (the fine was announced on the 18th Dec 1998). The authors were Michale Beloff QC and John Wilson

Our response

We understand your request relates to the Carlton/ITV documentary *The Connection*, and the ITC's investigation into this programme. Please see the attached document, which contains a press release, related correspondence, and the investigatory panel's report. Please note that we have made some redactions to these documents, as follows:

- Some of the information captured by the request contains personal information. We
 consider that this information is exempt from disclosure under Section 40(2) of the FOI Act,
 which provides that personal information about persons other than the requester is exempt
 where, among other things, its disclosure would contravene any of the data protection
 principles in the UK General Data Protection Regulation and the Data Protection Act 2018.
 Section 40 is an absolute exemption under the Act and does not require a public interest
 test.
- We consider that disclosure of some of this information is exempt under Section 44 of the FOI Act. In particular, section 44(1)(a) of the FOI Act exempts disclosure of information if its disclosure is prohibited under another enactment. Ofcom is prohibited under section 393 of the Communications Act 2003 ('the Communications Act') from disclosing information about a business which we have obtained in the course of exercising a power conferred by the

Communications Act among others, unless we have the consent of that business or one of the statutory gateways under section 393(2) of the Communications Act is met, neither of which applies here. Section 44 is an absolute exemption and therefore is not subject to a public interest test.

Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.
