We do hold a licence for the GMC and it is attached with this letter. The licence is a Business Radio Simple UK Licence which covers licence holders to use radio communications anywhere in land in the UK (but does not cover vessels) under certain licence parameters, for example, frequency and power.

We do not hold a licence for the GDC.

#### Request an internal review

If you are unhappy with the response you have received to your request for information, or think that your request was refused without a reason valid under the law, you may ask for an internal review. If you do, it will be subject to an independent review within Ofcom. We will either uphold the original decision, or reverse or modify it.

If you would like to ask us to carry out an internal review, you should get in touch within two months of the date of this letter. There is no statutory deadline for us to complete our internal review, and the time it takes will depend on the complexity of the request. But we will try to complete the review within 20 working days (or no more than 40 working days in exceptional cases) and keep you informed of our progress.
