# Freedom of Information request: Right to know request

Thank you for your request for information concerning Revolution Radio.

We received this request on 7 July 2025 and we have considered your request under the Freedom of Information Act 2000 ("the FOI Act").

## Your request

"Can you please confirm which company holds and is operating the Revolution Radio licence? According to the landlord Vulcan works as the following stations broadcasting from them. Horizon Radio ltd

Northampton Community Radio Ltd

What station does Northampton Community Radio Ltd broadcast as?

I suspect it's the new trading arm of Revolution Radio.

If they're not operating that license can you please confirm the studio location of Revolution Radio."

## Our response

The licence for Revolution Radio is held by Revolution Radio Limited.

Northampton Community Radio Ltd does not hold a broadcast licence from Ofcom.

While we hold some information about the studio location of Revolution Radio, we consider it is exempt from disclosure under Section 44 of the FOI Act. Section 44(1) of the FOI Act provides that information is exempt from disclosure if its disclosure is prohibited by or under any enactment. The enactment that prohibits the disclosure of this information is section 393(1) of the Communications Act 2003 ("the Communications Act"). Under this section, we are prohibited from disclosing information with respect to a particular business (such as radio broadcasters) that has been obtained in the exercise of our regulatory functions, unless that business consents or one of the statutory gateways under section 393(2) of the Communications Act is met, neither of which apply here. Section 44 of the FOI Act is an absolute exemption and therefore is not subject to the public interest test.

#### Request an internal review
