Far from creating lower prices through competition, this will effectively allow a <i>de facto</i> cartel between e.g. StarLink and Amazon to keep prices artificially high. |
| | Amazon, through its Kuiper project, represents yet another example of a highly centralized, profit-driven multinational corporation seeking to extend its dominance into yet another critical infrastructure sector, namely global communications. The UK should exercise extreme caution in granting control of strategic communication gateways to a company with a demonstrated history of market monopolisation, aggressive tax avoidance, and exploitative employment practices. |
| | Allowing a foreign-owned, U.Sbased tech giant to control satellite infrastructure within UK borders raises major questions about digital sovereignty, data jurisdiction, and national security. Amazon's close entanglement with U.S. government and intelligence contracts should give Ofcom and the UK Government pause. Approving this licence risks ceding too much operational control over UK data traffic to a company ultimately answerable to shareholders and foreign regulatory bodies. |
| | The UK is already home to multiple NGSO gateway stations serving systems like OneWeb and Starlink. The cumulative spectrum, physical, and regulatory impact of |

| | rapidly multiplying NGSO systems must be examined holistically. Approving this licence in isolation risks long-term congestion, regulatory arbitrage, and sustainability issues in both spectrum and orbital domains. Finally, another problem is: this may dis-incentivise central government from further funding expansion of existing ground-based infrastructure to reach remote and / or poorly served areas. Successive governments make much talk about investing in this area however very little progress has been made and targets for population coverage are routinely missed. There is a real risk that central government will roll-back these targets as a private company is providing a service. Given Amazon's widely-known aggressive tax avoidance as mentioned above, this is ethically questionable. |
