#### Section 1

# Summary

# **Purpose of consultation**

- 1.1 We are proposing to give a direction applying the electronic communications code set out in Schedule 2 to the Telecommunications Act 1984 (the "Code") on terms proposed in this consultation to CityFibre Metro Networks Limited, whose registered company number is 06586002 (the "Applicant"). Further background about the Code (including the procedure that applies in this context) is set out in Section 2 of this document.
- 1.2 Our reasons for that proposal are set out in Section 3 of this document and our draft direction applying the Code to the Applicant is set out in Annex 1 to this document.
- 1.3 The closing date for responses is 5 December 2011 and stakeholders wishing to respond are directed to Annex 2 for information on how to respond to this consultation.

### **Proposed application and terms**

- 1.4 The only purposes for which the Code may be applied in a person's case are:
  - 1.4.1 the purposes of the provision by him of an electronic communications network; or
  - 1.4.2 the purposes of the provision by him of a system of conduits which he is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.
- 1.5 Having considered the Applicant's application for Code powers, we propose that the Code should have effect in its case for two purposes: firstly, the provision by the Applicant of its electronic communications network in the United Kingdom; and secondly, the provision by the Applicant in the United Kingdom of a system of conduits which the Applicant is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their own networks.
- 1.6 According to the Applicant's application, its electronic communications network comprises a metropolitan dark fibre optic cable network which is deployed in ducts underground. Individual fibre strands are then connected to apparatus installed at customer premises. Signals are then conveyed through the Applicant's network providing, or with a view to provide, a variety of electronic communications services. As regards the provision of a conduit system, the Applicant explains that the ducts amount to conduits for the purposes of section 106(7) and it allows third party electronic communications network providers the right to deploy their apparatus in the Applicant's conduits and the Applicant intends to continue to do so.
- 1.7 We consider that our proposal is appropriate having regard to the considerations set out in section 107(4) of the Communications Act 2003, which four factors are central to our impact assessment. We therefore consider that the performance of our

- statutory duties in sections 3 and 4 of that Act would be secured and furthered in relation to this proposal.
- 1.8 We will, however, consider any responses we may receive by the closing date before making our decision as whether we should give a direction applying the Code to the Applicant.

#### Section 2

# Background

### The Code

2.1 The Code is designed to facilitate the installation and maintenance of electronic communications networks. It confers rights on providers of such networks and on providers of systems of conduits which are made available for use by providers of electronic communications networks for the purposes of the provision of those networks, to install and maintain apparatus in, over and under land and results in considerably simplified planning procedures. Other legislation may from time to time set out restrictions and conditions subject to which the Code applies.<sup>1</sup>

# The application of the Code

- 2.2 The Code only has effect in the case of a person to whom it is applied by a direction given by Ofcom (or, in the case of the Secretary of State or any Northern Ireland department, where the Secretary of State or that department is providing or proposing to provide an electronic communications network).
- 2.3 The only purposes<sup>2</sup> for which the Code may be applied in a person's case by a direction are:
  - 2.3.1 the purposes of the provision by him of an electronic communications network; or
  - 2.3.2 the purposes of the provision by him of a system of conduits which he is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks.
- 2.4 Of com may impose terms in applying the Code in the case of the person in question, particularly the Code may effect to that person:
  - 2.4.1 in relation only to such places or localities as may be specified or described in the direction:
  - 2.4.2 for the purposes only of the provision of such electronic communications network, or part of an electronic communications network, as may be so specified or described; or
  - 2.4.3 for the purposes only of the provision of such conduit<sup>3</sup> system, or part of a conduit system, as may be so specified or described.

# **Application process for applying the Code**

- 2.5 Of commust not give a direction applying the Code in any person's case except on an application made for the purpose by that person.
- 2.6 Any such application must be made in accordance with the requirements for the time being in force with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made.<sup>4</sup>
- 2.7 As regards the content of an application, the current requirements<sup>5</sup> state that an application must contain the following information:
  - 2.7.1 in the case of a company, the company name, company number, address of the registered office and details of any subsidiaries, parents and affiliates;
  - 2.7.2 in the case of a partnership, contact name and address, name of partnership, address of principal place of business;
  - 2.7.3 in the case of an individual, the individual's name, address and contact details:
  - 2.7.4 a description of the electronic communications network or system of conduits which the applicant intends to provide, including the location of that network or system;
  - 2.7.5 the person's reasons for wishing to obtain a direction applying the Code to him, including an explanation of why it would not be practicable to him to provide the network or conduit system without the Code;
  - 2.7.6 a description of the purposes for which the electronic communications network (if applicable) is to be used, for example the type of electronic communications service to be provided over the network and who is likely to benefit from that service;
  - 2.7.7 in the case of providers of systems of conduits only, written evidence that they are making available or proposing to make available their system of conduits for use by providers of electronic communications networks for the purposes of the provision by those providers of their networks (e.g. any available contracts, letters from providers of electronic communications networks confirming their intention of using that specific system of conduits for the provision of their networks);
  - 2.7.8 where the applicant is able and willing to share electronic communications apparatus, evidence of his ability and willingness to share such apparatus;
  - 2.7.9 where applicable, a description of alternative arrangements to the direction applying the Code which have been sought;

- 2.7.10 where available, a description of any measures taken or initiatives signed up to which demonstrate responsible use by the applicant of the Code; and
- 2.7.11 evidence of the applicant's ability to put in place funds for meeting liabilities as defined in restrictions and conditions referred to in sections 109 to 117 of the Communications Act 2003 prior to the exercise of rights conferred by the Code.
- 2.8 As to the manner in which an application is to be made, the current requirements indicate our willingness to receive applications for a direction under section 106 of the Communications Act 2003 transmitted by means of an electronic communications network.

### Time limit for making a decision on application

- 2.9 Regulation 3 of the Electronic Communications and Wireless Telegraphy Regulations 2011<sup>6</sup> makes provision about the time within which an application for a direction applying the Code must be determined by Ofcom.
- 2.10 Regulation 3(2) provides that, except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application. In other words, that time limit applies from the moment Ofcom receives an application that fully complies with the requirements discussed above.

### Statutory consultation process on proposal

- 2.11 Before giving a direction applying the Code to the applicant in question, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.<sup>7</sup>
- 2.12 Such a notification must contain the following<sup>8</sup>:
  - 2.12.1 a statement of Ofcom's proposal;<sup>9</sup>
  - 2.12.2 a statement of Ofcom's reasons for that proposal;
  - 2.12.3 a statement of the period within which representations may be made to Ofcom about the proposal (which period must end no less than one month after the day of the publication of the notification 10).
- 2.13 The publication by Ofcom of a notification must be a publication in such manner as Ofcom considers appropriate for bringing the notification to the attention of the persons who, in Ofcom's opinion, are likely to be affected by it.
- 2.14 The statutory notification published at Annex 1 to this document is a notification published for such purposes in the Applicant's case, which notification should be

read in conjunction with the entirety of this document, including the reasons set out in Section 3.

# Relevant considerations in making a decision (four factors)

- 2.15 In considering whether to apply the Code in any person's case, Ofcom must have regard, in particular, to each of the following matters<sup>11</sup>:
  - 2.15.1 the benefit to the public of the electronic communications network or conduit system by reference to which the Code is to be applied to that person;
  - 2.15.2 the practicability of the provision of that network or system without the application of the Code;
  - 2.15.3 the need to encourage the sharing of the use of electronic communications apparatus;
  - 2.15.4 whether the person in whose case it is proposed to apply the Code will be able to meet liabilities arising as a consequence of the application of the Code in his case and any conduct of his in relation to the matters with which the Code deals.
- 2.16 For the purposes of this process, those four factors rank equally with Ofcom's statutory duties under sections 3 and 4 of the Communications Act 2003. Where appropriate, outside of those statutory considerations, we will also have regard to any additional factors that, in our opinion, are relevant to the particular application.

# Statutory duties

#### **General duties**

- 2.17 In carrying out functions under the Communications Act 2003 (which includes giving a direction to apply the Code), Ofcom's principal duty is to further the interests of citizens in relation to communications matters and to further the interests of consumers in relevant markets, where appropriate by promoting competition.
- 2.18 In so doing, we are required to secure a number of specific objectives and to have regard to a number of matters, as set out in section 3 of the Act. As to the prescribed specific statutory objectives in section 3(2), we consider that the objective of securing the availability throughout the UK of a wide range of electronic communications services as particularly relevant to this consultation.
- 2.19 In performing that duty, we are also required to have regard to a range of other considerations, which appear to us to be relevant in the circumstances. In this context, we consider that a number of such considerations are relevant, particularly:
  - 2.19.1 the desirability of promoting competition in relevant markets;
  - 2.19.2 the desirability of encouraging investment and innovation in relevant markets; and

- 2.19.3 the desirability of encouraging the availability and use of high speed data transfer services throughout the United Kingdom.
- 2.20 We have also had regard to the principles under which regulatory activities should be transparent, accountable, proportionate, consistent, and targeted only at cases in which action is needed, as well as the interest of consumers in respect of choice, price, quality of service and value for money.
- 2.21 Ofcom has, however, a wide measure of discretion in balancing its statutory duties and objectives. In so doing, we will take account of all relevant considerations, including any responses received during this consultation process, in reaching our conclusions.

### Specific duties for fulfilling Community obligations

- 2.22 The function of giving a direction to apply the Code would involve us exercising functions falling under the EU regulatory framework. As such, section 4 of the Communications Act 2003 requires us to act in accordance with the six European Community requirements for regulation.
- 2.23 In summary, these six requirements are:
  - 2.23.1 to promote competition in the provision of electronic communications networks and services, associated facilities and the supply of directories;
  - 2.23.2 to contribute to the development of the European internal market;
  - 2.23.3 to promote the interests of all persons who are citizens of the European Union;
  - 2.23.4 to take account of the desirability of Ofcom's carrying out of its functions in a manner which, so far as practicable, does not favour one form of or means of providing electronic communications networks, services or associated facilities over another, i.e. to be technologically neutral;
  - 2.23.5 to encourage, to such extent as Ofcom considers appropriate for certain prescribed purposes, the provision of network access and service interoperability, namely securing efficient and sustainable competition, efficient investment and innovation and the maximum benefit for customers of communications providers:
  - 2.23.6 to encourage compliance with certain standards in order to facilitate service interoperability and secure freedom of choice for the customers of communications providers.
- 2.24 We consider that the first and fifth of those requirements are of particular relevance to our proposal in this consultation and that no conflict arises in this regard with the specific objectives in section 3 we have identified above as particularly relevant in this context.

#### Impact assessment and equality impact assessment

2.25 The analysis presented in the entirety of this consultation represents an impact assessment, as defined in section 7 of the Communications Act 2003.

- 2.26 Impact assessments provide a valuable way of assessing different options for regulation and showing why the preferred option was chosen. They form part of best practice policy-making. This is reflected in section 7 of the Act, which means that generally Ofcom has to carry out impact assessments where its proposals would be likely to have a significant effect on businesses or the general public, or when there is a major change in Ofcom's activities. However, as a matter of policy Ofcom is committed to carrying out and publishing impact assessments in relation to the great majority of its policy decisions. - 2.27 Specifically, pursuant to section 7, an impact assessment must set out how, in our opinion, the performance of our general duties (within the meaning of section 3 of the Act) is secured or furthered by or in relation to what we propose.
- 2.28 There are two main options for this consultation:
  - 2.28.1 give a direction to apply the Code to the Applicant; or
  - 2.28.2 not to give such a direction.
- 2.29 In carrying out our functions (again, something which includes giving a direction to apply the Code), we are also under a general duty under the Equality Act 2010 to have due regard to the need to:
  - 2.29.1 eliminate unlawful discrimination, harassment and victimisation;
  - 2.29.2 advance equality of opportunity between different groups; and
  - 2.29.3 foster good relations between different groups,

in relation to the following protected characteristics: age; disability; gender reassignment; pregnancy and maternity; race; religion or belief; sex and sexual orientation.

- 2.30 Such equality impact assessments ("**EIAs**") also assist us in making sure that we are meeting our principal duty under section 3 of the Communications Act 2003.
- 2.31 We have therefore considered what (if any) impact the proposal in this consultation may have on equality. We do not, however, consider the impact of the proposal in this consultation to be to the detriment of any group within society. We have therefore not carried out separate EIAs in relation to race or gender equality, or equality schemes under the Northern Ireland and Disability Equality Schemes.

#### Section 3

# Reasons for proposal

### Introduction

3.1 This Section contains the statement of our reasons for proposing to apply the Code to the Applicant.

#### **Factual matters**

### Receipt of a completed application

- 3.2 On 1 June 2011, we received in confidence a draft application from the Applicant attached to an e-mail. The Applicant also attached confidential and commercially sensitive documents concerning its business model with a plan of infrastructure.
- 3.3 On 29 June 2011, we advised the Applicant that we would require a completed application (non-draft) to be submitted addressing various points before we could fully consider it.
- 3.4 On 3 August 2011, we received a revised completed application from the Applicant, which is signed by its Chief Executive Officer. The Applicant also accompanied that application with a confidential and commercially sensitive business plan and a letter dated 2 August 2011 from the company's directors confirming that sufficient funds will be maintained to meet any specified liabilities as soon as reasonably practicable following the grant of Code powers.
- 3.5 On 4<sup>th</sup> October and 17<sup>th</sup> October 2011, we received further confidential information in relation to funds for liability and methodology.
- 3.6 Accordingly, we consider that the Applicant's completed application meeting the requirements described in Section 2 of this document was received on 17 October 2011.

### The person to whom it is being sought the Code should apply

- 3.7 According to the application, the person to whom it is being sought the Code should apply to is:
  - 3.7.1 Company name: <u>CityFibre Metro Networks Limited</u>
  - 3.7.2 Registered company number: 06586002
  - 3.7.3 Registered office: <u>271 Regent Street, London, W1B 2ES</u>
- 3.8 That person (the Applicant) is a wholly owned subsidiary of Cityfibre Holdings Limited, whose registered company number is 07488363.

# Description and location of the network or conduit system for Code powers, and of the purposes for which the Code is requested to apply

- 3.9 The Applicant explains that it is mainly in the business of providing an electronic communications network. That network comprises of a metropolitan dark fibre optic cable network which is deployed in ducts underground. Individual fibre strands are then connected to apparatus installed at customer premises in England, Scotland and Wales. Signals are then conveyed through the Applicant's network providing, or with a view to provide, a variety of electronic communications services. In particular, this network enables the Applicant to operate high speed broadband services and point to point solutions to businesses in the public and private sectors across the United Kingdom.
- 3.10 The Applicant intends to maintain, operate and expand the electronic communications network, which will involve deploying further fibre optic cables in ducts under public highways and private land to the above areas and also Northern Ireland. It has therefore requested that Ofcom does not impose any geographical restrictions on the locations for which any Code powers will have effect.
- 3.11 The Applicant notes that its electronic communications network has been installed in compliance with the relevant authorities. The Applicant also employs a full time noticing and street works coordinator who liaises with local and highways authorities.
- 3.12 The Applicant explains that, whilst the main focus of its business is on the provision of an electronic communications network, the Applicant is also in the business of providing a conduit system. The Applicant confirms that the ducts amount to conduits for the purposes of section 106(7) and it allows third party electronic communications network providers the right to deploy their apparatus in the Applicant's conduits and the Applicant intends to continue to do so. For this reason, the Applicant is seeking Code powers to apply also in relation to such provision.

# **Analysis of the four factors**

# The benefit to the public of the electronic communications network and or conduit system by reference to which the Code is to be applied to the Applicant

- 3.13 According to the application, the Applicant's network is used to transmit voice, data, video and television services to apparatus connected to customer premises. Its customers include businesses, schools, universities, healthcare centres, council offices, police stations and museums. In some cases, the Applicant states that it has allowed managed service providers to use its electronic communications network, which providers then have, in turn, allowed their own customers the right to use the Applicant's network.
- 3.14 The Applicant's confidential business plan also states that its expansion plans include other types of customers, who would benefit from its network. Third party providers of electronic communications networks also benefit from their contractual rights to deploy part of their networks in the conduits in which the Applicant has deployed its own electronic communications network.
- 3.15 For these reasons, Ofcom considers that Code powers would benefit the public as the network will serve both wholesale and retail customers and it is likely to increase

competition in the provision of various broadband and, telecom services across the United Kingdom in the future.

# The practicability of the provision of the electronic communications network and system of conduits without the application of the Code

- 3.16 The Applicant states in its application that it requires access to the public highway and private lands in order to efficiently build and maintain the infrastructure needed for its intended service provision. The application explains that Code powers will enable them to carry out street works in a more coordinated fashion providing the Applicant's services to homes and businesses more efficiently. The Applicant points to various practical and resource difficulties that arise in its case without Code powers and the implications they have on its business.
- 3.17 The Applicant also states that it would be placed at a competitive disadvantage if it would not be granted Code powers, as it would be unable to benefit from the same advantages available to its competitors to provide its network as efficiently and effectively as it is able.
- 3.18 The Applicant notes that its customers would also be detrimentally affected without Code powers, as the costs of connecting them to the Applicant's network would be far greater. This would again leave the Applicant at another competitive disadvantage.
- 3.19 The Applicant further states that it would be prevented from increasing competition, as it would not be able make its systems of conduits available to other electronic communication network providers as quickly and cost-effectively as possible without Code powers.
- 3.20 Ofcom considers that practicability of the provision of the Applicant's electronic communications network and, systems of conduits without the application of the Code is likely to be an issue to the Applicant. It is therefore possible that the Applicant could suffer certain disadvantages as compared to other providers. In this context, we have also had regard, in particular, to the scale of which the Applicant expects to deploy at least 15km of new electronic cables over the next 12 months.
- 3.21 The Applicant explains that the most viable alternative to Code powers would be multiple applications by it for street works licences to be granted by local highways authorities. However, in the Applicant's view, this alternative approach would be impracticable and involve unnecessary use of the resources of both the Applicant and the authorities, as well as lead to significant costs and delays whilst the authorities consider the applications. We are minded to agree with this assessment and that practicability is likely to be a real issue for the Applicant without Code powers.

# The need to encourage the sharing of the use of electronic communications apparatus

- 3.22 The Applicant confirms that it allows its customers access to its electronic communications network. The Applicant states that it also intends to allow service providers and other customers to have access to its network in order to deliver their services to end users.
- 3.23 The Applicant also confirms that it also intends to continue allowing third party providers of electronic communications networks the right to deploy parts of their

- network in the conduits which comprises of the Applicants electronic communications network.
- 3.24 We consider that sharing of the use of apparatus would be encouraged by granting the Applicant Code powers as a result of those confirmed intentions.

# Whether the Applicant will be able to meet liabilities as a consequence of (i) the application of the Code; and (ii) any conduct in relation to the application of the Code

- 3.25 The Applicant has considered what needs to be covered by the fund which it to implement in respect of specified liabilities. The Applicant has also reviewed the possible methodologies suggested.
- 3.26 The Applicant has calculated an expected annual maintenance cost per metre of network provided. A calculated amount has also been concluded for to cover specified liabilities during the liability period.
- 3.27 The Applicant enclosed a signed letter from its directors confirming the fund for specified liabilities will be put in to place, once Code powers has been granted. The Applicant proposes that it maintains this fund by way of an insurance policy.
- 3.28 The Applicant has provided Ofcom with evidence as to its ability to put in place funds for meeting liabilities arising as a consequence of the application of the Code and any conduct in relation to the application of the code.

### **Overall assessment**

- 3.29 Ofcom consider that our proposal would secure or further the performance of our statutory duties under sections 3 and 4 of the Communications Act 2003.
- 3.30 In particular, we consider that, if the Applicant's intended infrastructure plans through the use of Code powers are realised, there is prospect of its provision contributing to the availability throughout the UK of a wider range of electronic communications services. We also believe that there is prospect of competition in the provision of electronic communications networks and services and associated facilities being promoted by our proposal, including the encouragement of investment and innovation. The availability and use of high speed data transfer services throughout the United Kingdom would also be encouraged as a result of the Applicant's network of fibre optic cables.
- 3.31 The likely impact of implementing the proposal is likely to be low. Any costs to those affected by the Applicant's use of Code powers are likely to be outweighed by the benefits. On the other hand, the detrimental effect (including practicability, costs, time and resources) on the Applicant without such powers could be significant. As noted in Section 2 of this document, we are also of the view that the impact of our proposal is not likely to be to the detriment of any group within society.

# **Proposal**

3.32 For these reasons, we propose that the Applicant should be granted Code powers and that Ofcom should give a direction applying the Code to the Applicant.

# Ofcom's consultation principles

A2.1 Of com has published the following seven principles that it will follow for each public written consultation:

### Before the consultation

A2.2 Where possible, we will hold informal talks with people and organisations before announcing a big consultation to find out whether we are thinking in the right direction. If we do not have enough time to do this, we will hold an open meeting to explain our proposals shortly after announcing the consultation.

# **During the consultation**

- A2.3 We will be clear about who we are consulting, why, on what questions and for how long.
- A2.4 We will make the consultation document as short and simple as possible with a summary of no more than two pages. We will try to make it as easy as possible to give us a written response. If the consultation is complicated, we may provide a shortened Plain English Guide for smaller organisations or individuals who would otherwise not be able to spare the time to share their views.
- A2.5 We will consult for up to 10 weeks depending on the potential impact of our proposals.
- A2.6 A person within Ofcom will be in charge of making sure we follow our own guidelines and reach out to the largest number of people and organisations interested in the outcome of our decisions. Ofcom's 'Consultation Champion' will also be the main person to contact with views on the way we run our consultations.
- A2.7 If we are not able to follow one of these principles, we will explain why.

### After the consultation

A2.8 We think it is important for everyone interested in an issue to see the views of others during a consultation. We would usually publish all the responses we have received on our website. In our statement, we will give reasons for our decisions and will give an account of how the views of those concerned helped shape those decisions.

# [Proposed] Direction under section 106(3) of the Communications Act 2003 applying the electronic communications code

### **Background**

- 1. The Applicant has applied to Ofcom for a direction applying the Code to the Applicant.
- 2. The date on which Ofcom received a completed application that meets the statutory requirements with respect to the content of an application for a direction applying the Code and the manner in which such an application is to be made was 17 October 2011.
- **3.** By virtue of regulation 3 of the Electronic Communications and Wireless Telegraphy Regulations 2011 (SI 2011 No. 1210), except in cases of expropriation, Ofcom must make its decision within 6 months of receiving the completed application.
- **4.** Prior to giving a decision under section 106(3) of the Act to apply the Code to the Applicant, Ofcom must publish a notification of its proposal to give the direction and consider any representations about that proposal that are made to Ofcom within the period specified in the notification.
- **5.** On 3 November 2011 Ofcom published, in accordance with section 107(6) of the Act, such a notification of its proposal to give a direction applying the Code to the Applicant for the reasons set out in the consultation document accompanying that notification. That notification invited representations to Ofcom by no later than 5pm on **5 December 2011**
- **6.** Ofcom has considered every representation about the proposal received and duly made to it. For the reasons set out in the explanatory statement accompanying this Direction, Ofcom has had regard, in particular, to each of the matters set out in section 107(4) of the Act. Furthermore, Ofcom has considered and acted in accordance with its general duties in section 3 of the Act and the six Community requirements in section 4 of the Act.

#### **Decision**

- 7. Ofcom hereby directs, in accordance with section 106 of the Act, as follows—
  - (a) the Code shall apply to the Applicant for the purposes of the provision by the Applicant of an electronic communications network and, a system of conduits which the Applicant is making available, or proposing to make available, for use by providers of electronic communications networks for the purposes of the provision by them of their networks
  - (b) that application of the Code shall have effect throughout the United Kingdom.

- **8.** In this Direction, unless the context otherwise requires and subject to paragraph 9 below, words and expressions used in this Direction shall have the same meaning as they have been ascribed in the Act.
- 9. In this Notification—
  - (a) "Act" means the Communications Act 2003;
  - (b) "Applicant" means CityFibre Metro Networks Limited, whose registered company number is 06586002;
  - (c) "Code" means the electronic communications code;
  - (d) "Ofcom" means the Office of Communications.
- **10.** For the purpose of interpreting this Notification—
  - (a) headings and titles shall be disregarded;
  - (b) the Interpretation Act 1978 shall apply as if this Notification were an Act of Parliament:
  - (c) expressions cognate with those referred to in this Direction shall be construed accordingly.
- **9.** This Direction shall take effect on the day it is published.
