The holder of an analogue local commercial radio licence may apply to Ofcom to have the station's Format amended. Any application should be made using the layout shown on this form, and should be in accordance with Ofcom's published procedures for Format changes.¹ Under section 106(1A) of the Broadcasting Act 1990 (as amended), Ofcom may consent to a change of a Format only if it is satisfied that *at least* one of the following five statutory criteria is satisfied:

- (a) that the departure would not substantially alter the character of the service;
- (b) that the departure would not narrow the range of programmes available by way of relevant independent radio services to persons living the area or locality for which the service is licensed to be provided;
- (c) that the departure would be conducive to the maintenance or promotion of fair and effective competition
- (d) that there is evidence that, amongst persons living in that area or locality, there is a significant demand for, or significant support for, the change that would result from the departure; or
- (e) that (i) the departure would result from programmes included in the licensed service ceasing to be made at premises in the area or locality for which the service is provided, but (ii) those programmes would continue to be made wholly or partly at premises within the approved area (as defined in section 314 of the Communications Act 2003 (local content and character of services)).

Only one of these five criteria need be satisfied in order for Ofcom to consent to the proposed change. However, even if Ofcom is of the opinion that the proposed change satisfies one or more of the statutory criteria, there may be reasons (depending on the particular circumstances of the case) why Ofcom may not consent to the proposed change. The additional criteria to which Ofcom will have regard when exercising this discretion can be found on our website.²

Applicants should note that, under section 106ZA of the same Act (as amended), a proposed change that *does not* satisfy the first or last of these criteria (i.e. a change that Ofcom considers *would* or *could* substantially alter the character of the service, or does not relate to

the origin of locally-made programmes) must, if it is to be considered further under any of the other three criteria, be consulted upon.

In the event that Ofcom receives a request for Format change and considers that criterion (a) or (e) is *not* satisfied, it will seek confirmation from the applicant as to whether it wishes to proceed with the request (and, if so, whether it wishes to amend or replace its submission in light of the necessity to make it public).#

- a. The proposed change would not substantially alter the character of service. The change to local hours and programme sharing are in line with Ofcom's localness guidelines. The station will continue to provide bespoke local news and information for the Rutland and Stamford area.
- b. The departure would not narrow the range of programmes available. The station will remain the only one in the area providing bespoke local news for the Rutland and Stamford areas. The competitor stations are Smooth East Midlands, a regional station providing news for the whole of the region and Heart Cambridgeshire, from Peterborough, which covers the Stamford area but not Rutland.
- e. Programmes included in the licensed service will cease to be made at premises in the area or locality for which the service is provided, but those programmes will continue to be made wholly or partly at premises within the approved area.

Ofcom notes on the request

Statutory requirements

This request relates to the FM licence for Rutland held by Rutland Radio Ltd ('Rutland Radio'), currently broadcasting as Rutland Radio.

Every FM local commercial radio station is required to broadcast a service which complies with a defined 'character of service', and also a certain amount of locally-made programming and local news. These requirements are specified in its Format. Locally-made programmes are those made within a station's licensed area or, where Ofcom has approved a wider area relating to that station, that 'approved area'.

Rutland Radio has requested the following changes to the Format of the Rutland licence:

- To change its Character of Service description from "a melodic music and information station primarily for 25-54 year-olds in the Rutland and Stamford area, highly focussed on local issues" to "a melodic music and information station primarily for 25-54 year-olds with specific local news for the Rutland and Stamford area".
- To produce locally-made programming anywhere within the Ofcom approved Central⁵ area.
- To reduce the required number of locally-made programming hours on weekday daytimes from ten to three, and from four to none on weekend days.
- To increase the amount of local news broadcast from at least hourly at peak-times to at least hourly during daytime weekdays and peak-time weekends.
- To share all locally-made programming with the services provided under the West Midlands, Wolverhampton, Shrewsbury & Oswestry, Telford, Kidderminster and Stoke on Trent licences.

These proposed changes would change the character of service as set out in the Format of the licence, and accordingly can be agreed only if Ofcom is satisfied in regard to one of the statutory criteria set out in section 106(1A) of the Broadcasting Act 1990 (as set out in the request, above).

If we are satisfied in relation to one of the statutory criteria, we are then able to decide whether or not to approve the request, taking account of our published policy criteria.

Assessment

Proposed change to 'character of service'

With the regard to the proposed change to the Character of Service description, we were satisfied in relation to section 106(1A)(a) of the Broadcasting Act 1990 on the basis that this service would continue to be a melodic music station with an obligation to provide local news and information for the Rutland and Stamford area in a manner that is consistent with Ofcom's published localness guidelines.

We were also satisfied that there were no policy grounds upon which to reject this request, taking account of our <u>published policy criteria</u> on Format changes. In particular, for the reason set out above, we were satisfied that the extent of the impact of the change on the character of the Rutland Radio service would be limited.

Proposed changes to locally-made programming requirements

With regard to the request to broadcast locally-made programming from anywhere within the Central approved area, Ofcom was satisfied in relation to section 106(1A)(e) of the Broadcasting Act 1990, on the basis that the change requested, if approved, would result in programmes included in the licensed service being made at premises within the Central approved area.

In considering the proposed changes to the volume of locally-made hours, local news requirements and sharing all locally-made programming with other local commercial radio services in the same approved area, we were satisfied in relation to section 106(1A)(a) of the Broadcasting Act 1990 – that the changes would not substantially alter the character of service. This is because the proposals are consistent with our published <u>localness guidelines</u>.

In addition, as a matter of general policy, Ofcom is content to approve Format change requests relating to localness obligations which are consistent with our published localness guidelines and we are satisfied that the licensee will continue to meet its licence obligations to provide local material relevant to the listeners in its licence area.

Decision

Ofcom decided to approve this Format change request from Rutland Radio Ltd because we were satisfied in relation to two of the relevant statutory criteria, and for the policy reasons outlined above.
