1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a Community Digital Sound Programme (C-DSP) licence.
- 1.2 A digital sound programme service intended for broadcast by means of a local or smallscale radio multiplex service requires either a C-DSP licence or a local DSP licence. Ofcom's published guidance notes set out some of the key issues that potential applicants need to consider in deciding which type of licence is suitable for them. In summary, C-DSP services are not run for financial gain and are required to provide social gain. C-DSP licences therefore include strict conditions to ensure that happens, and provide less flexibility than a local DSP licence. However, they do provide access to capacity that small-scale radio multiplex service providers are required to reserve solely for C-DSP services.
- 1.3 A C-DSP licence will be required even if the same programme service is also provided on any other platforms (e.g. FM, satellite), as separate licences are required for those.
- 1.4 As noted above, small-scale radio multiplex services will have reserved capacity for C-DSP services. Issue of a C-DSP licence does not, however, guarantee carriage on a small-scale (or local) radio multiplex service. That is a matter for agreement between the C-DSP licensee and the multiplex service provider, and there may be more C-DSP licences issued in a locality than there are reserved slots on the small-scale radio multiplex service. Note that a C-DSP service does not necessarily have to broadcast using reserved capacity. It can use unreserved capacity on a small-scale radio multiplex service or capacity on a local radio multiplex service, again subject to agreement with the multiplex service provider.
- 1.5 An application for a C-DSP licence will be accepted only once Ofcom has advertised the licence for the small-scale radio multiplex service upon which the proposed C-DSP service is intended to be provided. There is no closing-date by which an application for a C-DSP licence must be submitted (i.e. it can be submitted at any time after the licence for the relevant small-scale radio multiplex licence has been advertised).

The company already offers a service on the South Shields and Tynemouth DAB Multiplex, which has been running since December 2021 and is currently financially secure. This finance is met via government funding, grants, sponsorship, advertising and donations. Our South Shields service has secured sponsorship that will support the two community radio services.

Affinity Media NE CIC has secured funding from the local councils, Sir James Knott Trust, Northumbria Police and Crime Commissioner, Dogger Bank Windfarm, Inspire South Tyneside, and The Barbour Foundation. We're currently working on funding bids that will continue to support our Newcastle and Gateshead radio service. The company has secured two dedicated colleagues who apply for funding on the organisation's behalf.

Affinity Radio has already secured two sponsors, which are two local businesses in the Newcastle and Gateshead Areas. These include a popular entertainment venue for live music performances, a restaurant, café and takeaway, a children's home, and two Newcastle schools with which we are going to be working in partnership offering work experience, airtime to children and young people. Newcastle City Council have already approached Affinity Media to broadcast from local community festivals in the late summer of 2024.

Our vision for a cross platform community media service draws on Newcastle and Gateshead's history and culture of creativity and innovation. In music, art, design and manufacturing and the whole areas of Newcastle and Gateshead's authentic stories to tell of a rich and fascinating local heritage, a dynamic current environment full of talent and ambition, and exciting prospects for future development.

Our goal is to establish an inclusive and sustainable local radio station that shows what is vibrant and distinctive about Newcastle upon Tyne and Gateshead, that meets the public interest in local news and information, and that offers a platform for local opinion and creative expression. Affinity Radio will inform, educate and entertain. To these core purposes of public service broadcasting, we will add opportunities to participate - "Making Waves across Newcastle and Gateshead - Made by You" - providing public access to facilities, programme maker support, professional training and mentoring.

Broadcasting on DAB to Newcastle and Gateshead will allow local businesses, communities to come together to deliver a real local community radio service.

3.6 How will you ensure that your proposed C-DSP service is run on a not-for-profit basis? Answer in fewer than 400 words. Affinity Radio will be run by volunteers. In the future, we aim to secure funding for such positions; Volunteer Coordinator and Business Development Manager. All money received, whether by monthly subs or advertising rates, Grant funding is strictly controlled and only used for purposes that would benefit the station i.e. equipment upgrades or payment of any service bills, running costs; rent and licences required to continue broadcasting. Affinity Media NE CIC holds this responsibility to ensure it is correctly administered.

Any payments out have to be signed by two authorised people and the money can't just be dipped into by unauthorised people. Any surplus generated will be invested in the organisation that delivers the service.

As set out in our business plan Affinity Media NE CIC will apply for funding for a Station Coordinator, support staff who would be employed as a community support worker to meet our companies aims and objectives.

Our organisation provides a platform for local groups and societies to promote their events and organisations through us both on air, our website and on social media. We are also keen to get involved with community events and providing entertainment; Affinity Radio will specialise in its local and unique talent across Newcastle upon Tyne, Gateshead and the surrounding area already we have programmes in the pipeline that dedicate airtime for each musician, poet or whatever their talent to be heard on-air.

Affinity Radio will be located in within the Newcastle and Gateshead area therefore, we are happy to support local businesses and the local authorities getting their message across to our listeners.

Our focus on the Newcastle and Gateshead multiplex is to operate a service that welcomes all as mainstream community radio station.

All shows presented on Affinity Radio will be in a non-biased way and offer listeners various ways to interact and get involved in discussions & shows. We also have regular studio guests from the community who get the chance to promote their own services on air no matter what they are. All presenters will adhere to Ofcom broadcasting code and our company policies and full training will be given so all volunteers remain nonbiased throughout any discussions on live radio.

Our volunteers will be drawn from all backgrounds and walks of life, as well as presenting shows volunteers will be encouraged to go out into the communities of Newcastle and Gateshead and surrounding areas to report on local stores and engage with members of the public and other local businesses and community groups within the areas. This builds on developing strong relationships with the local authorities and other local providers in the transmission area.

Informed Interview and induction where full training for the role they have applied for.

DBS checks carried out by the local authority to ensure we are recruiting suitable people to work with us and in the communities that we serve.

The Training Module covered includes;

Induction to the organisation and our expectations and rules and policies.

Shadowing Managers and other presenters.

Our core management team of experienced volunteers who have worked in both community and commercial radio will be responsible for delivering the training to non-experienced volunteers.

We want to take part in as many community activities whether it be working with the local authorities, businesses or charities our slogan is "Making Waves across Newcastle and Gateshead" so no matter how big or small an event is we want to know about it, as it's important to us as a pillar of the local community. Affinity Media has already been asked by Newcastle City Council and other charities when we go on-air if we would attend their community event and broadcast live.

Any local business who is looking to launch, can contact us for promotional packages and we have the equipment and trained presenters available to provide live promotion on site with music. This includes a radio ad, promotional space on the station's website and social media.

Upon Success of our application to hold a CDSP for Newcastle and Gateshead our station would help launch businesses live onair and provide live entertainment.

The station is provided to the local community and is entirely reliant on volunteers to operate. The station broadcasts 24 hours a day, 7 days a week.

The core aims are:

• Be a source of entertainment and information for the communities in Newcastle upon Tyne, Gateshead and the surrounding areas,

• Provide a voice for local individuals, charities, organisations and good causes

• Give a platform to local performers and artistes

• Provide volunteering opportunities which encourage workplace and life skills for diverse communities across the area

We value equality, diversity and inclusion, encouraging people from all backgrounds to get involved with the station. We are developing links with local colleges and schools to involve young people in the station.

We provide high-quality, cost-free education projects and training, focusing on creative media production as well as key social and employment skills to the local community.

The station offers radio training as a route to gaining confidence and improving communications skills for the younger unemployed people locally across Newcastle and Gateshead. We welcome those considered as disenfranchised to inspire them to discover and maximise their abilities and increase their self-confidence.

We intend to undertake outside broadcasts across the transmission area which will highlight our commitment as a community broadcaster. We will showcase the fact that we are run by, and require, volunteers. Some of these broadcasts will take place from charities and local good causes, giving them a voice and a platform to a greater audience across the community on the airwaves.

The service is provided to the community and is reliant on volunteers to support the organisation and provide its broadcast services. Volunteering will continue to be open to all individuals from across Newcastle and Gateshead. However, this is subject to satisfactory completion of standard volunteer recruitment checks, induction processes and appropriate training to meet their role.

A large variety of roles will be open to members of the target community (and others), including onair presentation, production, programme scheduling, journalism, fundraising, engineering and technical, administration, finance, and promotion.

Affinity Media NE CIC already benefits from the experience and knowledge of our existing 43+ volunteers and we expect that this number will increase should a Newcastle and Gateshead CDSP radio licence be granted. There will also be opportunities to be part of the management team of the station for volunteers with the relevant skills that match with the job descriptions of the management roles.

The station also intends to actively encourage other organisations to get involved in its programming, whether as volunteers for the station or simply as guests on programmes. We are already in discussions with a number of organisations these include two schools and a number of charities to get their voices on-air.

We intend to promote getting involved with us via a number of platforms such as our website <u>www.affinityradio.uk</u> and <u>www.affinitymedia.uk</u> and through social media channels such as; Facebook, X and Instagram. Volunteer roles provide opportunities for members to develop technical skills and experience, build confidence and improve interpersonal skills, enhance skills in management, customer services and communication. We will also run regular volunteer with us adverts on-air as well as working with local volunteering organisations across Newcastle and Gateshead to promote this.

Our South Shields and Tynemouth service "Radio Shields" already works alongside The Customs House, which offers arts and entertainment for all, serving the residents of South Tyneside and beyond with a varied programme of live performance, cinema, visual arts and projects for children and young people. Affinity Radio will work alongside theatre and art centres such as Theatre Royal, Tyne Theatre and Opera House and The Glasshouse in Gateshead.

We aim to facilitate interested youth groups to attend an 'Open Session' or work with local schools to accommodate work experience, where they can get to see how our station works and become a presenter on a show. Similarly, as we develop our relationships with 'Hard to Reach' groups we will offer the opportunity to be involved in the creation of programmes specific to each group, particularly as they will have expert knowledge related to their individual position within the community.

Accountability

We are available for contact pretty much 24/7 via our studio phone lines/text or on our social media platforms such as WhatsApp, Facebook, Instagram and X. We also have a messaging service and ways to interact on our website.

Members of the public and the local community in Newcastle, Gateshead and beyond will be invited to give feedback at an open evening once a year. The open evening will consist of all the upcoming and future plans of the station as we develop. We will also send out surveys into the community asking them to provide feedback on our service.

Kyle has over 19 years of broadcasting experiences and understands Ofcom's broadcast code and key commitments from previous community radio station involvement. Co-Directors and future managers will be trained on the relevant points of these documents also. Kyle is trained in media studies as well as other members of the trustee's team who will assist the organisation in these areas. The organisation has appointed a volunteer to act as compliance officer who will ensure that compliance of all broadcasts is met and will obtain relevant logs as required.

The Station Manager and Chairman founded the organisation in 2019. He is the designated Relevant Person. He has 19 years of experience in a variety of roles gained at community radio stations across the North East. In that time, he has developed a thorough knowledge of OFCOM regulations, law as it applies to broadcasters and the day-to-day management of a community radio station. The Relevant Person has assembled a core team of experienced volunteers who assist him with the strategic and day to day management of the radio station. Their specific expertise is in radio programming, media law, OFCOM regulations and technical support.

He is experienced in training and managing teams of volunteers, giving particular attention to compliance and legal issues as they relate to broadcasting. He also has a wide technical knowledge and is able to maintain and update the broadcast and IT systems. The chairman has media qualifications where he gained the knowledge and experience to enable him to run a community radio station. This was completed in 2012 and is relevant to the newly CDSP license. We have experience running an Ofcom licenced radio station which is called Radio Shields and runs on the South Shields, Tynemouth SCDAB multiplex.

These include:

- Ofcom regulations and how they affect our station
- Retention of recordings broadcast for 42 days
- Programme content specifically offensive language, religion, taste and decency etc.
- Annual licence fees (PRS & PPL)
- Complaint handling
- Advertising and Promotion
- Election rules for broadcasters
- Obituary and major story procedures

Four named Directors

These individuals are the named directors for the company of Affinity Media NE CIC which is listed on Companies House. They perform the statutory roles of a company director and are responsible for the South Shields and Tynemouth SCDAB service; Radio Shields and will be responsible for the Newcastle & Gateshead service; Affinity Radio.

Social Media Manager

A social media manager will manage our online presence by developing a strategy, producing good content, analysing usage data, facilitating customer service and managing projects and campaigns. This covers Facebook, X and Instagram.

Programme Manager

The programme manager will plan and develop the schedule of programmes for the station in conjunction with the Station Manager. They will ensure that station output complies with the policy guidelines agreed with this our community radio policies and are in line with the relevant Ofcom Broadcasting code of conduct

Music Manager

The music manager will work alongside the programme manager and will ensure that all audio is vetted before it plays on the station.

Producers

Producers work with the presenter to research for content and ensure that we engage with our local community and make sure that shows are engaging with the listeners.

Finance Manager

The finance manager will work alongside the stations directors to make sure that the finances are correctly managed.

Compliance Manager

The compliance manager will work alongside the programming and music manager and will be overseen by the board of directors to ensure full compliance is met for every broadcast. They will be responsible for ensuring that all logs of what has been aired is logged and updated on the compliance spreadsheet along with declaration forms for all volunteers and Media release forms for any guest speakers.

4.4 How does the applicant intend to formally train staff in compliance procedures? Please include details of the compliance training that will be given to those responsible for live programming, including compliance staff, presenters and producers.

Our volunteers will be drawn from all background of the communities across Newcastle and Gateshead including; hairdressers, professional managers, disabled people, university students and more.

Our volunteer programme helps more people to reach their potential, by supporting them at the earliest possible stage. This is completed via visibility and participation in the local area.

All volunteers will be provided with induction training and all necessary training for the relevant role with Affinity Radio. Any roles that are related to on-air work, volunteers will be trained using our studio equipment, general presentation and interviewing skills mentored by an experienced journalist.

This training will be led by our organisation training manager and some of the stations more experienced volunteers.

The timescale of training depends on each individual volunteer and their outside commitments, but we expect most new volunteers to complete their training within 3-4 weeks.

All staff and volunteers are required to read and agree on the station's rules/handbook and procedures guide, which sets out the rules and procedures they are required to adhere to when broadcasting and involved in our organisation. This document is covered during training for new members and its available to all presenters in the studio and via its communication portal.

The broadcasting Code is also covered during training and a link to Ofcom website is available at the stations volunteer handbook which is in the studio at all times.

There is on-going monitoring of shows plus on-going training in-house with a minimum of 2 presenter refresher sessions each year.

Affinity Media NE CIC has its own HR and has a number of training resources on the portal to ensure the safety of all volunteers.

For programmes and features produced by outside sources e.g. syndicated show, the programme will come from presenters who are fully aware of their responsibilities and the shows will be monitored to make sure of full compliance is adhered. 4.5 Will the training described in response to question 4.5 be mandatory for all staff and volunteers? The station keeps all show / programme log sheets in either computer and / or paper copies are kept for archive purposes.

All our audio is logged onto our systems and is retained for achieved purposes.

The management team is fully briefed on the content of Ofcom's broadcasting code and it is a core part of the training which all volunteers much complete before producing content for the radio station or the social media channels.

Affinity Radio will be making sure that all automated and pre-recorded shows and upcoming presenters will be properly vetted as we will request a sample show to be sent to us first and we can either accept or decline the show if it does not meet Ofcom standards.

We will be encouraging that presenters will be listen in to each other's shows in order to prevent any breach of policy and any music that is found to be unsuitable for broadcasting will be highlighted by the presenter and will be removed immediately. There will be a vetting process of the music on the system to try and prevent this from happening, this is why we now have a dedicated volunteer who ensures our music is correctly vetted

The responsible person, company directors and experienced members of the team will ensure that compliance is met within our key commitments and will meet as a management team at least once a month to discuss how the community radio station is doing, and what it can do to better the station, and volunteers within it.

Our Programme Manager will be responsible for ensuring that programming commitments are being kept to and will ensure that all output from the station is recorded and kept for a period of 42 days from the day of broadcast.

The station Manager and Program Manager will have regular programme meetings each week and monitor the stations output and keep ongoing records of what the station has done to fulfil its commitments.

We keep records of our interviews that we have broadcast and the files are logged for many of these programmes and then retained for archive purposes.

Community interviews will also be published on our website and be retained as part of the website archive to demonstrate how we have fulfilled our commitment.
