1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a Community Digital Sound Programme (C-DSP) licence.
- 1.2 A digital sound programme service intended for broadcast by means of a local or small-scale radio multiplex service requires either a C-DSP licence or a local DSP licence. Ofcom’s published guidance notes set out some of the key issues that potential applicants need to consider in deciding which type of licence is suitable for them. In summary, C-DSP services are not run for financial gain and are required to provide social gain. C-DSP licences therefore include strict conditions to ensure that happens, and provide less flexibility than a local DSP licence. However, they do provide access to capacity that small-scale radio multiplex service providers are required to reserve solely for C-DSP services.
- 1.3 A C-DSP licence will be required even if the same programme service is also provided on any other platforms (e.g. FM, satellite), as separate licences are required for those.
- 1.4 As noted above, small-scale radio multiplex services will have reserved capacity for C-DSP services. Issue of a C-DSP licence does not, however, guarantee carriage on a small-scale (or local) radio multiplex service. That is a matter for agreement between the C-DSP licensee and the multiplex service provider, and there may be more C-DSP licences issued in a locality than there are reserved slots on the small-scale radio multiplex service. Note that a C-DSP service does not necessarily have to broadcast using reserved capacity. It can use unreserved capacity on a small-scale radio multiplex service or capacity on a local radio multiplex service, again subject to agreement with the multiplex service provider.
- 1.5 An application for a C-DSP licence will be accepted only once Ofcom has advertised the licence for the small-scale radio multiplex service upon which the proposed C-DSP service is intended to be provided. There is no closing-date by which an application for a C-DSP licence must be submitted (i.e. it can be submitted at any time after the licence for the relevant small-scale radio multiplex licence has been advertised).

The target community is the Panjabi speaking people in Leicester. The Panjabi speakers originate from the Panjab area of North India and Pakistan but are now into the fifth generation who have settled over here in Leicester. The people are mainly of Hindu, Muslim and Sikh faiths but share a common language, Panjabi.

The broadcast provision will cater for all ages with a wide genre of music covering bhangra dance, poetry, ballads, folk, classical and traditional.

The broadcast service will provide access to those who are at work or in education as well as those who are socially isolated, excluded, unemployed, disaffected, housebound, frail elderly, parents of preschool children who cannot access information through the normal media channels mainly on account of having English as a second language or no grasp of the English language. The broadcast service will provide culturally appropriate entertainment with the objective of increasing intergenerational understanding and thereby strengthening community cohesion through local civic pride and participation to increase tolerance and understanding across the communities.

- 3.6 How will you ensure that your proposed C-DSP service is run on a not-for-profit basis? We have been operating as a not-for-profit organisation since 2008. Any profit will, as in previous years, be reinvested back in to the company to accommodate keeping the studio equipment fully operational through replacement or refurbishment for the benefit of the community broadcasting. The surplus funds will also be used to support running costs, upgrades, maintenance and workshops to bolster the achievement of our Social Gains. Accounting procedures have been in place since 2009 to meet all financial criteria for operating a community radio station.

Social gain

- 3.7 What community benefits will your service bring to your target community(ies) and, if applicable, the general public. Kohinoor FM broadcasts mainly to and for the Leicester Panjabi community with information and programmes for the varied social, cultural, religious, music, sports, youth, disabled and minority activities and interests of the community. Local business and community organisations are encouraged to sponsor or advertise on air. Kohinoor FM operates a 24 hour service, 7 days per week.

The services that Kohinoor FM provides are entirely unique. Programmes are presented by members of the local Panjabi community and focus on community information to provide participatory programming covering local issues, health, welfare, culture and social engagement. Debates and phone-ins on community and other topics of interest to listeners are encouraged.

Relationships have been developed with relevant statutory and voluntary organisations and projects that can provide a better quality of life for the benefit of the Panjabi community.

We highlight and showcase all the differing organisations and events specific to the Panjabi community. We have developed good working relationships with Leicester City Council, Leicester CCG, NHS Departments, Police, Local Gurdwaras/Temples and Community Centres, Grassroots football (girls and boys) cricket and hockey clubs, Women support groups where we work on projects and provide on air information to the community.

Workshops and project have been held with NHS departments for Better Health to reduce Obesity, Winter Vaccines, Silver Bus Diabetes testing, Mental Health Awareness along with many other health projects.

Projects with the Leicester City Council have included promotion of Fostering, Recycling, Energy Saving Grants for small businesses and How To Stay Safe At Diwali.

Other projects have been for awareness and promotion of supporting Domestic Violence victims, Drug & Alcohol Abuse with Turning Point, Business Fire Safety Events with Leicestershire Fire & Rescue Service, Improved Nutrition with Elephant Atta and Anti- Grooming with Sikh Helpline.

Kohinoor FM will continue to be actively involved in providing more socially and personally relevant projects in the future.

Kohinoor FM has organised events and been involved in the promotion of a wide range of community events ranging from live music concerts to poetry readings, Vaisakhi and Diwali festivals, drama productions, health workshops, community debate events, and sports festivals .

Kohinoor FM has provided and will continue to provide training opportunities for a wide range of participants which have included partially sighted, wheelchair users and those with learning disabilities, mental health issues and various other medical conditions.

All of these activities are leading to social cohesion, social gains, equality of access to information, and opportunity for the Panjabi target community.

Kohinoor FM facilitates and will continue to facilitate discussion and the expression of opinion by :

- Hosting live phone call-ins on discussion on matters of interest.
- Having invited community guests, specialists and invited speakers as panel members to ask and answers questions, provide information,
- Going out into the community to hold consultations, seminars in community centres, youth clubs, colleges, to build on the ongoing consultations and expression of interest. We have found this approach to be most useful in engaging with the target community.
- Ensuring speech content is at least 30% to allow inclusion of discussions.

Kohinoor FM offers radio broadcasting, training, air time and open days to encourage participation by Panjabi community organisations and individuals

Since our first broadcast in 2009 we have carried out regular training for interested people and provided them with air time or involvement in other aspects of the broadcasting. We have a dedicated training person along with a group of senior members who induct and train new people.

Training to members of the community is available through on-site and off-site links with other organisations on e.g. IT training, vocational, volunteers placements, production of radio programmes, all resulting in the raising of self esteem, confidence, and certificated approval, or participation certificates.

Access by community members and training is vital to ensure success of our social gain objectives. The parameters we use are:

- Provision of training or education – we will maintain an inclusive, open access operation and freely offer opportunities for informal training to people who desire and show a suitability to become a radio presenter. We have built up our presenter team from people who had no previous broadcasting experience – including young and elderly people, and disabled – and will continue to offer opportunities to new people.
- Young local children will be involved in competitions, including broadcasting on air. Visits to the studio by youth groups plus individuals and groups of children with special needs are encouraged and take place regularly. On each of the visits there are opportunities for visitors to go live on air.
- Members of our target community make suggestions as to the types of programmes and music they want to hear. These proposals are always formalised by the management group and appropriate programmes are then put on air.
- Provision of training in office administration including the use of the internet to research and find information is provided.
- Provision of training in studio operation and presenting. Newcomers are trained in the following disciplines/skills: audio desk and audio device use, microphone techniques, computer-based play-out systems, programme preparation and programme presentation. All trained people are given the opportunity of live presenting.
- Kohinoor FM takes on students 16-18 year olds from local schools for training and work placements arranged by Leicester College and Leicester Education Business Company. These placements are generally of 1-4 weeks duration and provide a good insight into different areas of community broadcasting.

- 3.10 How will your service provide better understanding of your target community and the strengthening of links within it? **Answer in fewer than 200 words.**

The Radio station supports and assists the target community in organising community events including carnivals, community processions, educational seminars and fairs, get-togethers, Diwali road show supported by Leicester City Council and talent shows to highlight cultural heritage and richness of the Panjabi speaking community of all faiths. These events allow Kohinoor FM to formally and informally engage with the community in different environments to constantly improve our understanding of the community changes and allow us to adapt our broadcasting accordingly.

Poetry and folk ballad evenings are a regular feature and attract a different genre of listeners. Dharmic music is also very popular and programmes are dedicated accordingly with live participation.

The radio disseminates information about community events and thereby encourages multi-agency and voluntary partnership working.

Kohinoor FM holds Quarterly discussion forums with the community to further allow expression of views and ideas and acts as a communication point for the community

Links will be further strengthened by involving members of the community in all aspects of radio broadcasting including input into programming, presenting news compilation, editing, presenting publicity newsletter, plus the presentation of cross generational programmes and programming.

- 3.11 Please summarise the relevant experience of the group or its members in activities related to the provision of social gain or other relevant non-broadcast areas (such as third sector, training or education). **Answer in fewer than 200 words.**

Kohinoor FM has a very experienced management group with skills and expertise that cover a very extensive area of relevance to the broadcasting. Additionally there is core group of presenters who have been involved in radio broadcasting for over 20 years each. Overall the group has members who have professional qualifications and experience in project management at a corporate level, teaching, engineering, law, quality deliverance, diversity and equal opportunities, media studies, counselling, public speaking, financial management and operating community groups. Other providers have been partnered when required from Leicester College and Leicester University.

Participation

- 3.12 How do you propose to ensure that members of your target community(ies) are given opportunities to participate in the operation and management of the service? **Answer in fewer than 400 words.**

All of the current members of the management & volunteers are from the local community. As such, further people are encouraged to join the team to take part in whatever aspect of the station they feel comfortable with. There are always over 100 people involved as volunteers.

Lack of experience is not a barrier. People are encouraged to participate in the following ways:

- Provide inputs or be directly involved in Interviewing, Presenting, Office Tasks, Liaising With Voluntary Groups/Charities/Schools/Youth Clubs.
- People are encouraged to participate via on air promotions.
- Guests and visitors are always encouraged to provide comments about the radio and its activities. Listeners are able to and do contribute via surveys, e-mail, SMS text message and letter.
- Avenues are regularly open for people to serve on the management steering committee on a rotating basis. The management advertises extensively for public participation as the aim is to operate with a mainly volunteer staff.

The events and activities in the community are regularly broadcasted and community organisations are encouraged to provide input into the programming and where suitable be involved in broadcasting. There are several community groups who have regular programmes on the radio.

Accountability

- 3.13 How will members of your target community contact your service and influence its operation? **Answer in fewer than 300 words.**

The station receives continued evaluation from the management team as well as local community associations. Continued assessment both written and by telephone is encouraged on a regular basis. The community is encouraged to provide feedback and this is then acted upon by the management to satisfy community requirements.

Kohinoor FM encourages contribution through e-mails, SMS text message comments and other social media applications.

Presenters are also asked to encourage listeners for comments and suggestions during their shows to be sent to us. These are then discussed and responded to by the management.

Kohinoor FM provides a consistently high quality of live events which encourages a wide cross section of its listenership to attend and participate. These include regular gigs with a range of music genres, poetry readings, drama performances as well as informative sessions attended by local businesses. Attendees are always encouraged to discuss their views at these events with regards to operation of the radio station.

More formal quarterly meetings are held with community groups to illicit feedback and discuss our objectives to ensure we keep providing the appropriate broadcasting for the community.

Kohinoor FM has developed a successful feedback / comments / complaints procedure. Any suggestions and criticisms are addressed by the management at its monthly meeting and resolved with urgency.

An open door policy is operated for any member of the public to visit and make comments/suggestions that are then passed onto the management.

Community members are encouraged to meet the staff or presenters in person at festivals, events and open days.

The named Director in part B is responsible for compliance and was trained in 2009 when Kohinoor FM first started broadcasting, and then further trained at several compliance workshops. The Station Manager has the daily responsibility for compliance and reports to the Director who has total overall responsibility. Both are totally familiar with The Ofcom Broadcasting Code, The BCAP Code and the Phone-paid Services Authority Code of Practice. Kohinoor FM is a member of the Community Media Association and uses their support network as required.

The named Director has over 15 years experience in radio broadcasting and the Station Manger has 30 years experience in radio broadcasting. In this time both have had responsibilities of broadcasting compliance. They are fully conversant with compliance responsibilities and the Ofcom Broadcasting Code. The Station Manager delivers compliance training to all members and volunteers on a regular frequency and is supported in this role by other senior members who have worked in Radio and other media industries. Our training sessions are updated regularly to include all new information regarding compliance.

- 4.3 For each role within your compliance team please provide job title and a brief description of the functions of the role specific to ensuring compliance of the proposed service. Please do not give names of individual members of staff – this question relates to job roles rather than currently employed individuals.

There are five members from the Management team in the Compliance team. The team consists of:

- Director, overall compliance responsibility
- Station Manager, day to day compliance responsibility, training responsibility, ensures all programmes and creatives are in compliance with requirements
- Studio compliance officer, ensures all presenters/volunteers have been trained, maintains all records, monitors content
- Engineering compliance officer, ensures all broadcast engineering is in accordance with guidelines and recording is in adherence of Ofcom requirements
- Financial compliance officer, ensures all accounting strictly adheres to Ofcom Codes, works closely with the Accountant

The Ofcom Broadcasting Codes are always available and accessible for everyone involved. All presenters are volunteers and are given appropriate compliance training as part of their induction.

- 4.4 How does the applicant intend to formally train staff in compliance procedures? Please include details of the compliance training that will be given to those responsible for live programming, including compliance staff, presenters and producers.

The Station Manager provides training to all presenters and volunteers before they start presenting live programmes. This training includes going through the regulatory rules of the Ofcom Broadcasting Code, BCAP Code and Phones services codes and Kohinoor FM guidelines. The training is mainly in house but sometimes an outside body is used. Meetings are held with all presenters on a monthly basis to provide updates and to address any issues regarding compliance and other matters. Kohinoor FM has developed, with modifications every year, a handbook for all presenters detailing the good and bad practices of presenting. These are provided to all presenters.

After completion of induction and training all presenters and volunteers are required to confirm, by signing the confirmation form, that they understand the regulations of broadcasting and advertising codes.

Training mentioned above is mandatory for all and staff and volunteers. Compliance with the Broadcasting and Advertising codes is given prominence above all other matters to ensure everyone involved at the radio station is fully aware of the regulations. Refresher training is provided annually for all and training is modified annually to keep abreast of changes.

- 4.6 It is a licence requirement that a licensee must ensure that all programming on its service (broadcast at any time of the day or night) complies with Ofcom's codes and rules (e.g. Ofcom's Broadcasting Code, which sets requirements on standards to be observed in programme content for the protection of the public).

Presenters are only allowed on air after they have completed the formal induction and training which includes compliance training. Every presenter is therefore aware of the Broadcasting Codes and ensures they and any guests on air stay within the guidelines. The Director and the Station Manager monitor all presenters and have also put into place that all presenters listen to any other programmes they can to support each other to ensure that everyone is fully compliant. Guests are always briefed about the codes prior to going live on air either by the Station Manger or the presenter. Procedures are in place to ensure that a programme is stopped immediately if the Director, Station Manager or other presenter feels there are issues with any programme being non-compliant.

The broadcasting is recorded at all times and randomly used in workshops for compliance and training. An emergency contact is always displayed in the studio for support if required.

Kohinoor FM very rarely uses pre-recorded material. If pre-corded material is to be used the presenter has to have this cleared by the Station Manager before it is broadcasted. The Station Manager will check any pre-recorded matter to ensure it is in compliance with all Broadcasting Codes.

The management review all programming on a monthly basis. Programmes are planned and produced to ensure compliance with our Key Commitments. All presenters discuss their format and content programming on a regular basis and this is then monitored by the Station Manager who reports back to the management which then assess if the programming content is appropriate. This information is then published and discussed with community members at quarterly meetings and also provided at the events organised by the radio station.

Kohinoor FM's named Director will be responsible for ensuring our compliance with the station's off-air social gain activities. These will be reported at the monthly management meetings and the quarterly meetings with the community. These activities primarily involve community engagement to ensure we are delivering the right programming content, community empowerment to ensure participation and accountability, provision of training and maintenance of records and preparation of all reports. Appropriate compliance has been maintained since 2009 when Kohinoor FM first started broadcasting.
