# 1. Overview

# The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised).The application form is divided into two parts Part A (which we will publish on our website) and Part B (which will be kept confidential). This document constitutes Part A; Part B of the application form is available on our website.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.
- 1.3 You can find more information about small-scale radio multiplex licences in Ofcom's published guidance notes for licence applicants and licensees. This document also includes detailed instructions on how to complete the application form, and information on the next steps in the application process. Please read this guidance and the 'frequently asked questions' carefully before completing both parts of the application form.

## **Provision of information**

We are looking to achieve very good outdoor coverage and good to very good indoor coverage across as much of the licence area as possible.

We achieve this with the use of four transmitters.

- Shilbottle to cover Alnwick and northern area
- Morpeth to cover the central area of the polygon
- Cramlington to cover Cramlington
- Clifton Lane to cover Ponteland and the southern area

The coverage has been planned to provide as consistent experience of reception as listeners would expect to national and existing local DAB services in the Alnwick and Morpeth area.


Coverage has been deliberately planned in such a way to ensure overspill outside of the Alnwick and Morpeth polygon is as minimal as possible.

The sites we have selected have taken in to account ACI and interference with cochannel multiplexes.

We have identified a fifth site, which would help boost indoor coverage in the south east of the polygon but it is outside the strict criteria laid out in Ofcom's Guidance Notes. Details have been provided in confidence in Part B of the application and, subject to this application being successful, we would wish to

discuss this site's implementation with Ofcom since it would improve the listener experience and is also compliant regarding interference and overspill.

## **Financial and business plan**

3.24 Explain how the applicant considers it will be able to establish its proposed service. This should include an explanation of the costs required to establish the multiplex service, and how these costs will be met:

The applicant is a newly established company owned and run by experienced operators of DAB and SSDAB services.

Ash Elford is the majority shareholder. Ash has established an enviable reputation as one of the pioneers of SSDAB. Ash is responsible for the day-to-day management and strategy of the multiplex. He has established the applicant entity to provide an effective management and ownership platform for SSDAB operations.

Nation Broadcasting is a minority shareholder. Nation is the UK's third largest operator of local commercial radio licences and has interests in a number of local DAB multiplexes across the UK. It has considerable DAB launch and operating experience, including in SSDAB, having owned and operated the Glasgow trial multiplex since 2018.

The applicant will utilise its existing SSDAB interests as a foundation to successfully launch in the area. We will work closely with our service providers in community radio/ C-DSP services in the area to promote the launch of SSDAB in Alnwick and Morpeth.

Our experience gives us full knowledge of the costs and risks associated with the launch and operation of the multiplex.

UK DAB Networks Ltd will benefit from Nation Broadcasting's group infrastructure, bringing a significant credit and finance function and with the ability to share best practice across corporate areas such as HR and technology. This will free us to focus on providing an excellent service to listeners and its service providers.

Capital requirements of transmitter and associated equipment will be provided through loans from our minority shareholder, Nation Broadcasting. We will contract with the transmitter site owners for rental. Multiplexing software will be sourced from the world's leading multiplex software firm Factum Radioscape, a majority Nation owned company. Day to day operating costs will be met through renting capacity on the multiplex to third parties.

We propose to charge local community operators who hold a C-DSP licence on a de minimis basis. This is because we know that these services are run as not for profit operations and we want to help them keep costs down. Given our investment in transmission, we believe that all local community and C-DSP services will take us up on this offer.

We will charge third party operators a monthly fee.

Any shortfall/losses will be borne by loans from our minority shareholder Nation Broadcasting, though our projections show that we will operate the Alnwick and Morpeth SSDAB licence at an operating profit.

## **Relevant expertise and experience**

Day-to-day management of the multiplex will be by Ash Elford, owner of UK DAB Networks Ltd, a new DAB multiplex consultancy, ownership and operating company.

Ash is one of the UK's pioneers in SSDAB and has overseen the establishment and successful operation of the nearby Portsmouth SSDAB trial. Ash has also been working with Nation Broadcasting for a number of years and has overseen the significant improvement in the reliability, coverage and services on the SSDAB Glasgow trial. Ash was previously engaged in the DAB digital radio team at Arqiva.

Director Jason Bryant has been involved in the development and rollout of DAB in the UK since the launch of the first national multiplex in 1999. He represented the original Talk Radio and Virgin Radio channels on Digital One. He has won and launched a large number of DAB multiplexes – including in London, Scotland and Wales. Jason led Nation Broadcasting's investment in Factum Radioscape, one of the World's leading software providers of DAB multiplex software and monitoring systems.

Martin Mumford, Nation's Managing Director, will oversee the finance and compliance functions for UK DAB Networks Ltd. Martin has longstanding experience in managing successful multiplex businesses.

In addition to being director of UK DAB Networks, Alan Beech has a long history in transmission engineering working for a utility company, Arqiva and now his own company, Commtronix Ltd. Alan has been involved in transmission system installation and maintenance of DAB equipment for over a decade, and since 2015 has taken an active role in Small Scale DAB. Alan's forward thinking meant that Commtronix were the first company to provide AAC+ licenses to enable the roll out of DAB+ on Small Scale DAB multiplexes in the UK. Alan will be at the heart of engineering.

Our plans for Alnwick and Morpeth include the provision of four transmission sites. We expect the multiplex to be operational within 12 months of licence award.

Multiplexing and encoding will be done using the Factum Radioscape Enmuxa platform which provides a world leading multiplexing system providing good quality audio on a robust system. The Enmuxa platform is highly flexible and will be ready in ample time before launch.

In addition to the technical requirements, soon after award we will commence the procurement of telecoms and establish transmission contracts with service provides.

A project plan is included in Appendix I.

We are experienced in the establishment of multiplexes from application through to launch and will capitalise on this to ensure a smooth launch of the multiplex.

# Demand or support from programme providers

The Act is clear that it is desirable to provide a platform for C-DSPs. We have made plentiful provision for community radio and services operating under a not-for-profit basis.

In Alnwick and Morpeth, we have involved community radio operators and those who will likely operate services under a C-DSP licence. This is evidenced by Ash Elford's track record of working with community services on the Portsmouth and Glasgow trial multiplexes over the past five years.

We propose the following C-DSP services to be carried on the Alnwick SSDAB multiplex.

- Lionheart Radio Existing FM community broadcaster
- Radio Northumberland Existing FM community broadcaster

We are aware that there are potential C-DSP services involved with another application for Alnwick & Morpeth. We will offer them the same terms as the above services for reserved capacity.

More generally, for DSPS providers, given our experience of the SSDAB trials in Portsmouth and Glasgow, the publicity and response to our published plans, and the fact that our team is well known and highly regarded in the industry, we have not been surprised to receive substantial interest from putative operators in Alnwick & Morpeth.

Consequently, the SSDAB multiplex will launch with a strong line up of commercial programme services and we have submitted our preferred line up of services confidentially to Ofcom, based on a number of factors including track record, variety and localness.

# 5. Fair and effective competition

#### About this section

In preparation for our licence application, we have made several announcements to the trade press through 2020 inviting interested broadcasters to talk to us. We have also invited broadcasters that we have relationships elsewhere with to join our application.

As a minimum we will:

- Provide a website and social media channels regularly inviting interested broadcasters to contact us
- Publish a ratecard for multiplex capacity
- Provide capacity at a de minimis rate to C-DSP services, making use of reserved capacity
- Work to ensure that multiplex is as fully utilised as possible
- Allocate capacity in a way that promotes the greatest diversity of formats and providers in the event of demand for multiplex capacity exceeding supply.
