A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). This document constitutes Part A; Part B of the application form is available on our website.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process.

 Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.
- 1.3 You can find more information about small-scale radio multiplex licences in Ofcom's published <u>guidance notes</u> for licence applicants and licensees. This document also includes detailed instructions on how to complete the application form, and information on the next steps in the application process. DAB Leeds Ltd will encourage as many local services to join the multiplex as possible.

Up to thirteen commercial radio services will be charged £99.00 a week to join the multiplex.

Seven C-DSP community services will be charged £55.00 a week . Community radio services may be gien a discount depending on their circumstances.

We will reserve one channel for pop-up services – equivalent to the current temporary RSL services. This will be for a low or nominal charge to benefit the community.

We will fund this with £30,000 start up capital which has already been raised

The transmitter site will cost £15,000 to install (see costs below.£15,000 to install (see costs below.

Our DAB multiplexer and encoders will be the cloud based Radioscape Enmuxa system. By using Radioscape we can be sure that we will get a professional quality multiplexer that will be compatible with all UK tick mark tested radio receivers.

We will have a mix of five DAB services and the rest as DAB plus services. Having some "original DAB" services on the multiplex will ensure that all DAB receivers in Leeds, even older ones that cannot decode DAB plus, will be able to receive our services.

In addition we will reserve 8 KBIt.S for a DAB SPI channel – to contain limited service information and station logos. This will ensure our services display well on all receivers with screens, including car radios.

Our directors all have a history with volunteering for the community, and supporting the Arts and local Broadcasts.

Once the site has been approved, we can proceed with procuring transmitter site equipment and internet connection circuits.- This process will be completed 12 months from receipt of licence.
