Halifax is the principal town of the Calderdale district in the Yorkshire and Humber Region. It has a population of 70,507. The town is located, for the most part, on low ground to the north of the river Calder, but is surrounded by high terrain, often well in excess of 200 meters A.O.D.

This means that higher radiated powers would do very little indeed to increase population coverage, as the topography very much dictates the extent of signal reception.

The nature of this topography also means that even coverage of the wider advertised area is not possible from a single site. In addition, the scale of the advertised area (just 175,720 adults total) means that a second or third site is not financially viable, at launch.

The directors are mindful of the need to take a prudent approach, rather than an over optimistic one, which in turn could lead to financial unsustainability.

Once established, Halifax DAB would seek to extend signal coverage as far as is practicable while taking account of the regulatory restrictions currently in force between participants in Halifax DAB, Bradford Digital Media (small-scale) and the Bradford and Huddersfield LRMS.

The town of Halifax represents 40.1% of the advertised area and two radio services, community radio station Phoenix Radio (a participant in Halifax DAB) and Sunrise Radio Yorkshire (by virtue of an FM Halifax relay transmitter) currently serve this single urban area.

Of note, there is likely to be substantial erosion of the advertised area's population by neighbouring small-scale multiplex services.

To the north east of the advertised area there is already overlap with the Bradford small-scale DAB licenced area which is operated by participants in this application. Notably the localities of Clayton and Buttershaw are served by Bradford Digital Media.

To the south the Huddersfield advertised area makes significant inroads into the Halifax polygon notably in the areas of Elland, Greetland & Stainland and Rastrick, areas with a total adult population of 28,416.

The north east and southern areas of overlap account for, we estimate, 23% of the hitherto viable polygon area reducing the advertised area in real terms to 147,304 adults. This suggests that our proposed Halifax coverage would account for 48% of the population of the wider area.

In this application, we propose to serve the town of Halifax by reaching 83.6% of this urban area. Please see table below:

Co-block mitigations

The licence advertisement proposes block 8B for use in Halifax which has encouraged us to take a highly cautious approach in determining transmitter ERP.

This was necessary to go some way towards mitigating the otherwise destructive interference which would be caused to the adjacent area - Bradford small-scale DAB multiplex, which also operates on 8B.

Upon award, we would wish to explore with Ofcom if a more suitable spectrum resource exists. Once this has been determined, it may be necessary to propose a different antenna pattern and radiated power level.


Our technical partner suggests that 9C may be a more suitable block for use in Halifax.

Financial and business plan

3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

The procurement of assets will be funded primarily by shareholder loans – repayable over the early years of the licence period. The company benefits from one principal investing shareholder, Infocus Digital Media, who is well placed to ensure adequate resources are available to deliver this service well within the fixed 18-month timescale. Infocus Digital Media will lend 85% of the required capital in order that the company may plan, purchase and build-out the radio multiplex over a twelve-month period. To determine the scale of this required expenditure, a detailed budget has been produced. The costs have been taken from a line-by-line listing of components and other areas of cost. This in turn has been validated against a detailed quotation from Digris, business knowledge and operational experience, and applied to this Halifax DAB multiplex licence application.

A similar approach has been taken in assessing the revenue potential from this DAB multiplex service. Supporting information can be provided to Ofcom on request.

As may be seen from the figures set out above, with the company being capitalised at £25,000 and initial costs of £18,000 including pre-operational expenditure, the radio multiplex service would launch with a surplus of £7,000 plus any pre-payment income from carriage customers. This gives our company confidence in being able to establish the proposed service.

Importantly, their previous relevant experience outlined briefly below will be supplemented by support from Digris, our transmission partner who will plan, implement, build-out, test and maintain the transmission aspects of the service going forward.

Digris will also handle the distribution of audio material and the multiplexed signal in our setting.

Howard Priestley

As Howard Priestley began his formal Art training at Stourbridge College, he became a regular contributor to the British Comics scene and a regular writer and illustrator for a variety of music publications.

A lifetime interest in Black culture has led him to interview several major individuals from Reverend Jesse Jackson to Eddie Holland. He designed CD covers and wrote sleeve notes whilst being instrumental in launching Phoenix FM which he still manages.

As a qualified youth worker and teacher in Special Educational Needs he has supported many people to be a part of this unique community resource and has written the station's policies and procedures.

Because of his teaching and training experience he has developed volunteers/placement and presenters' training manuals as well as preparing the company accounts and managing sales.

Through his work Phoenix Radio Howard has won several local and national awards based on his passion for the town and its heritage and he has worked with many sections of the

community of Halifax trying to ensure that all sectors of the community have equal access to the station.

In 2022 he was awarded a Community Spirit Lifetime Achievement award in recognition of the work he has done for the local community. The same year New Haven published his first book "Love Factory: The History of Holland Dozier Holland" which won an

Association for Recorded Sound Collections Awards for Excellence in Historical Recorded Sound Research in America.

His local knowledge has been instrumental in inspiring a diverse range of prospective

stations to join Halifax DAB.

Usha and Raj Parmar

Usha and Raj spearhead the Executive team at Sunrise Radio (Yorkshire) where as director/shareholders they utilise on a daily basis, a wide range of governance, compliance, broadcasting, general managerial and leadership skills.

These range from management and administration of sales contracts to overseeing programming and presenter direction, studio management, project management, accounting, sponsorship and airtime sales, marketing, website design and maintenance, creating social media initiatives and through other businesses – project, event and logistics management.

Usha and Raj have made their mark over a number of years as highly successful radio station operators and their proven track record shows that they are more than capable of contributing to the management and establishment of the multiplex and are able to conduct successful relationships with those seeking carriage.

Together they have led Sunrise Radio (Yorkshire) as early adopters of DAB radio broadcasting. In 2004 two Sunrise services were carried on the Bradford and Huddersfield multiplex. Today the company holds a DSP licence and in addition to broadcasting on the 'relevant' local DAB multiplex, Sunrise was one of the first radio companies to reach audiences via the Manchester and Glasgow small-scale DAB trial multiplexes.

In 2020 Usha and Raj founded Infocus Digital Media. They were awarded the Bradford small-scale radio multiplex licence in July 2021 and are members of consortia that were awarded the small-scale radio multiplex licence for Bradford, Leeds, Blackburn Burnley and Darwen, Oldham & Rochdale, Milton Keynes and Derby licences.

Halifax DAB: award to operationally live in 12 months

Experience drawn from previous rounds has shown that securing effective site agreements has the capacity to absorb a disproportionate and significantly large amount of time.

We plan to save a significant amount of time in the establishment of this service because our proposed site is already in use through Sunrise Radio and participants in this application enjoy a good working relationship with the site owners Calderdale College.

Additionally, we have made allowances for other factors such as the availability and supply of equipment and components, into our roll-out timetable.

In order to accurately assess the length of time it will take to reach full operational capability; we have identified seven elements to achieve a successful launch and incorporated these into our high-level Gantt chart.

We anticipate launching the radio multiplex within 12 months from date of award of licence although in reality we expect this to be sooner.

Our high-level Gantt chart lists 26 key activities grouped together under seven headings.

While many individual activities (shown in green) will be resolved within four to ten weeks, certain activities will take longer to conclude. We have indicated these in the Gantt Chart. We have shown any potential overruns in yellow on the plan.

Supported by the Gantt chart, submitted as Annex 5, the chart illustrates those activities, dependent upon predecessor activities being concluded, we are led to our assessment that without overruns, we can expect to be operationally live within 12 months from award.

Measures taken prior to Ofcom's advertisement announcement

A long association between the Directors of Infocus Digital Media, Phoenix Radio and Communities Together has been cemented through this application.

Infocus Digital Media initially reached out to services that might be interested in broadcasting in our area including Phoenix Radio and Radio Sangam who today are both shareholders in Halifax DAB and intend to be service providers should our company be awarded a licence.

Approaching potential programme service providers following Ofcom's advertisement announcement.

During this period Halifax DAB launched its website which also attracted interest.

Measures taken in our dealings with C-DSPs and DSPs

Our dealings with all prospective digital sound programme providers have been level, open and transparent. Our Heads of terms of Agreement form is standardised with common terms. It shows indicative prices for carriage whether these are heavily discounted carriage costs for community radio (C-DSPs) or showing the full standard indicative price.

Measures we will take during the licence period

Our website will showcase our finalised carriage charges and the process of applying for carriage. We will pledge on the website that we will not charge more than the rate-card rate shown.

To promote competitive entry, applications for carriage will not be assessed purely on economic grounds.

To this end we have developed a trading policy. Our policy for trading in a fair and

competitive environment embodies four overarching thresholds and our application procedure will be a three-stage process. Our thresholds include aspects such as localness, extent of appeal and robustness of the proposal. Applicants will be encouraged to make their case in the submission of their expressions of interest. Our process includes sifting and reviewing applications and placement on a waiting list. Upon conclusion, uniform carriage agreements with shared basic terms will be issued to service providers.

We believe that in adopting this structured approach we will demonstrate fairness in a manner that will stand up to scrutiny.

Overall, by embodying all the elements above, in particular our role in encouraging inclusivity, Halifax DAB can be seen to have developed a rigorous framework with defined areas of activity. This framework when taken as a whole, should, we trust, be seen to have been constructed in a manner calculated to ensure fair and effective competition in the selection and engagement of programme services for carriage on the Halifax DAB small-scale DAB radio multiplex.
