## 1. Overview

## The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts Part A (which we will publish on our website) and Part B (which will be kept confidential). This document constitutes Part A; Part B of the application form is available separately.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process. Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

## How to complete the form

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our <u>guidance notes</u> for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.

Sufficient information must be supplied about the applicant and the proposed service to enable Ofcom to consider the application in accordance with the statutory criteria for the granting of small-scale radio multiplex licences. Ofcom may need to request further details from you before a licence can be granted.
- 1.7 Of com reserves the right to reject applications made using an old version of the form.
- 1.8 Ofcom will accept handwritten application forms, but they must be filled in using block capitals and black ink.
- 1.9 Of com reserves the right to reject application forms that are illegible.

- 1.11 Ofcom reserves the right to reject applications which do not meet the following criteria:

  - i) A director of the company or the company secretary where the applicant is a company.

Our technical plan has been designed to cover the Sunderland SSDAB polygon as advertised by Ofcom, to include the Sunderland city area as well as surrounding populations of Houghton-le-Spring, Mount Pleasant and Washington to the west. Coverage is also provided to small and medium sized villages.

Our proposition is founded on three principles:

- 1. Working to the original DCMS/Ofcom objective to make DAB, available for community radio, and affordable for small independent commercial stations and start-up services within the Sunderland polygon;
- 2. Achieving the above within a sustainable, long-term business plan.
- 3. Delivery of a reliable, consistent, and high-quality DAB service to as much of the indoor population of this polygon as possible within the financial and technical constraints of an area that consistently ranks high in many IMD deprivation league tables.

The advertised polygon covers Sunderland and the surrounding area; it includes densely populated areas of Sunderland and Washington and some less densely populated areas to the south and west, containing some small and medium sized towns and villages.

Local topography dictates, to provide full good 'indoor' coverage to all parts of the polygon would require two transmission sites; our preference being for a primary installation at a proposed site at Haining, and a second in Sunderland City Centre or at Hendon.

It is worth noting that our assessment also revealed a likelihood that the existing Hendon Arqiva transmitter to the east of the city would cause hole punching into any service provided from either a Hendon site location or a city centre site.

Regardless, our analysis of likely income and cost indicates that a two-site solution would be financially unviable at present. We have concluded, therefore, that our proposal should be for a single transmitter at Haining which will cover key parts of the city, together with Houghton-le-Spring, Washington and surrounding areas.

A second site installation to fill in shadow and hole punching at Hendon will be considered once the primary site operation proves financially stable.

Saying this, we have already identified a suitable site in the Hendon/Grangetown part of the city, approximately 148m from the Arqiva Hendon transmission site that will provide service fill for both Haining shadow in the city and Hendon's hole punching locally.

In predicting coverage, we note that existing FM transmissions from the adjacent Arqiva mast at Haining deliver a robust service across the advertised area and expect, therefore, that 'indoor' coverage will be good in most parts of the polygon.

Furthermore, we note that our proposal is predicted to deliver excellent mobile coverage across large parts of the polygon. We expect that this will allow our service providers to be able to deliver their services robustly to a large proportion of the population.

The ward-level population tables (2011 Census) indicate that at 63 dBμV/m field strength;

- the number of people falling outside the polygon does not exceed 30% of the total population within the advertised licence area; and
- the proposed coverage does not overlap more than 40% of the population within the relevant local radio multiplex service's licensed area.

The transmitter network has been designed to minimise any significant interference above 38 dB $\mu$ V/m to other proposed small-scale DAB licence areas.

## Financial and business plan

3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

#### Establishing the Multiplex

The characteristics of the area covered by the polygon means that we expect to achieve good coverage with a single, suitably sited, transmitter

We forecast that start-up costs are in the order of £25k, of which £20k relates to the cost of the transmission equipment that will be required for the proposed transmitter site.

The additional funding relates to costs expected to be incurred before income is generated including site surveys, minor modifications, rent paid in advance, Ofcom fees and insurance.

These costs are based on quotes received from our technology suppliers, Viamux, and the real-world experience of directors of the costs incurred in setting up SSDAB services in Newcastle and Gateshead, Tynemouth and South Shields, Darlington and Bishop Auckland and Alnwick and Morpeth.

By carefully selecting our transmission site, using local knowledge and the networks of our participants, we have managed to keep set up and running costs at a cost-effective level.

#### **Financial Forecast**

We have attached a confidential spreadsheet as **Appendix C** that sets out the income and outgoings included in a 5-year cashflow forecast. Based on our experience, not all prospective service providers that have signed Heads of Terms will launch on the mux, therefore, for planning purposes we have assumed a realistic number of customers, generating a modest income.

  - a) Share capital

The company has no shareholders, but will be funded initially through loans from directors/members.

b) Loan stock

It is expected that much of the capital requirement will be secured through grant funding. Alternatively, funding is also expected to be made available, if required, through a blended loan/grant product. For the purposes of business planning it is assumed that funding would be achieved through a successful application to the Northern Impact Fund, offering funding that comprises a blend of loan (at an interest rate of 6.5%) and a grant of 30% of the loan value.

Should this not be forthcoming, alternative funding up to 100% of the requirement will be provided through loans from directors/members.

c) Leasing/HP facilities (capital value)

There is no requirement for Leasing/HP facilities.

d) Bank overdraft

e) Grants and donations

It is our intention to fund the company largely by grants and the rest from loans, if required. We have undertaken extensive research into the availability of grant funding in the area and are confident that much of the capital requirement can be raised as grant funding. The company is a not-for-profit social enterprise operating in communities which are characterised by high levels of deprivation which makes the initiative eligible for a range of funding opportunities. The directors have significant experience of obtaining grant funding for similar propositions.

We have included a confidential summary as Appendix L that describes our grant and loan funding research in more detail.

As stated in 3.18e above, the applicants are confident that significant grant funding can be achieved. Directors have experience in obtaining significant levels of grant funding working with a number of local and national social enterprise lenders and funding agencies and trusts.

The company is a not-for-profit social enterprise operating in communities which are characterised by high levels of deprivation which makes the initiative eligible for a range of funding opportunities. Potential grant funders have been approached to gauge support and feedback has been encouraging, although funders that have been contacted advise that they are unable to consider applications until such time as the licence is awarded.

We have included a confidential summary as Appendix L that describes the grant and loan funding options in more detail.

Loan funding is, however, available if required through loans from directors/members; evidence is provided as Appendix K.

Should the licence be awarded, the applicants will immediately initiate activity to secure the necessary grant funding.

## Relevant expertise and experience

Members of the Sunderland Digital Radio team share a track record of successfully establishing and operating SSDAB multiplexes, community radio stations and DSP services. The combined experience demonstrates these capabilities and gives us an excellent understanding of what is required: good coverage, service reliability and easy access for programme providers at an affordable and realistic price.

#### **General Management**

The directors will undertake the routine day-to-day management of the multiplex - managing commercial, financial and operational matters.

Launching, establishing and maintaining a DAB multiplex requires technical competence, operational expertise, financial stability, and an aptitude to manage third party relationships successfully. The directors are recognised as experienced radio managers with a broad range of relevant skills in all the vital functions required to operate a successful multiplex.

The day-to-day tasks will include;

- supporting, maintaining and upgrading the multiplex hardware and software;
- recruiting new services to ensure that the multiplex can generate commercial income;
- negotiating carriage agreements;
- invoice management and payment collection; and
- working with programme services to ensure DSPS and regulatory licence compliance.

Sunderland Digital Radio will benefit from Optimux – a software platform specifically developed for the day-to-day management of small-scale DAB multiplexes. Optimux equips small-scale DAB licensees with an easy to use dashboard for managing, monitoring and reporting on all aspects of their multiplex as well as providing invoicing and direct debit collection to simplify the payment of carriage fees. Optimux will play an essential role in streamlining the management of our multiplex.

Viamux will be responsible for the setup and launch of the multiplex, for ongoing maintenance of the transmission equipment, day-to-day technical management and maintenance of the multiplexing equipment.

Sunderland Digital Radio will internally oversee any multiplex re-configurations, and these will be undertaken in line with our policies and contractual agreements with service providers. Financial management of the multiplex will also be handled in-house:

- Accounts;
- IT;
- Admin;
- Legal;
- Customer Service;
- Technical Support.

#### **Key Personnel**

#### Richard Finch (Sound People Limited)

After graduating from university Richard spent over 35 years working in the retail financial services in a number of senior management roles. In 2011, Richard set up his own Management Consultancy, focusing on retail payments and provided consultancy to important national clients.

Richard has also volunteered at Radio Tyneside for over 40 years and as a Trustee for 20 years. For the last 12 years he has held the role of Station Director, responsible for the administration of the station which has held an Ofcom community radio licence since July 2018. Richard was a key member of the team that developed and submitted the licence application and is currently the main contact for finance and administration matters.

#### Jonathan Morrell (Sound People Limited)

Jonathan Morrell is a broadcaster and journalist of 35 years' experience. He currently works for the BBC in Cumbria as a Senior Broadcast Journalist. With the exception of a few years in London and Australia, Jonathan has worked in the North East on radio and TV for the entirety of his career. He has extensive contacts within the media and the North East broadcasting community.

Jonathan established Pride Radio 15 years ago following a successful 4-week RSL. 8 years later he successfully applied for and secured the finance to set up the station as an FM community broadcaster. This work has given him an insight into the operation of community stations and their needs going forward.

His strong connection with the area is reflected in the multiplexes proposed channel line-up – a number of existing and new services to the area, many which are locally based and inspired.

Together, Jonathan and Richard Finch set up Tyneside Community Digital CIC which has been operating the SSDAB multiplex in Newcastle and Gateshead successfully since launch in July 2022. Richard and Jonathan are also key members of the team that successfully applied for and operate the SSDAB multiplex for Darlington and Bishop Auckland and of the team that have been awarded the licence for the Alnwick and Morpeth SSDAB multiplex.

#### **David Roberts**

A veteran of North East broadcasting. Presenter/Reporter/commentator on BBC Radio's Cleveland and Newcastle, BBC Look North, TFM Radio, Metro Radio, Magic/GNR and Century Radio. External to the region, Dave also worked in similar roles for Hallam FM, Talk Sport, BBC Radio 5 Live, Talk TV, ITV and Sky TV. The latter he established and managed SKY's North East editorial bureau, where he was Bureau Chief and North East Reporter. As well as this, Dave built and operated 5 RSL broadcast training programmes (Kix FM x3 and The Point x2) in the region.

Internationally, Dave became a senior media executive when working for TV networks ESPN and Fox, the latter saw him lead both programming and business development as Vice President up until 2015, when he returned home to his native North East.

Dave then operated his award-winning media production business, XCel Broadcast, as well as launching Mux One & RedArmy Group operations to successfully secure the licences for both, the UK's first permanent small-scale DAB multiplex (Tynemouth & South Shields) as well as North East LDSP radio services, The Toon, The Cat and The Red.

Dave still consults for international networks ESPN, Fox and Discovery.

#### Richard Berry

Richard Berry is a Senior Lecturer in Radio at the University of Sunderland, where he has been teaching radio to undergraduate and postgraduate students since 1997. After a period of RSL broadcasts, Richard led a team that successfully applied for a community radio licence for the university. Spark (CR000143) launched in 2009, has won national and international awards and is a proven training ground for talent in the radio industry. Richard brings experience in operating the City's only analogue community radio station. He also has strong links to community radio regionally and nationally through academic work and as a former director of the Community Media Association.

#### Scott McGerty

Scott is a Presenter, Podcaster, Producer and Director well embedded into the North East radio scene. Scott has volunteered as a Presenter at Spark, Sunderland's only Community station, since it launched in October 2009 and then created a show called Dance Revolution. During this time Scott has also worked as a Producer at Metro Radio (Nightowls with Alan Robson) and is the current host of the Amazing Chart on Amazing Radio (since 2012). In January 2016 Scott started the role of Spark's Compliance Manager with the objectives of overseeing the day to day running of Spark and has ensured that the station is very much engrained in the everyday life of young people in Sunderland. Scott has thrived at developing young talent and has played a part in success stories of many working in brands such as BBC Newcastle / BBC Sunderland, Hits Radio North East (formerly Metro Radio), Capital, Heart, Kerrang, Radio X, BBC R1 and BBC 6 Music. In 2021, Scott expanded his Dance Revolution show on Spark into a 24/7 Small Scale DAB station also called Dance Revolution. This stations broadcasts on small scale DAB across Newcastle, Gateshead, North Tyneside, South Tyneside, Darlington, Newton Aycliffe & Bishop Auckland and Scott's Spark/Dance Revolution syndicated show acts as a training ground for Spark Volunteers and University of Sunderland Students who are keen to understand how to run a small scale station. Not only does Scott have extensive contacts in the regional and national radio network but he has strong relationships across the City of Sunderland with Community Groups, Charities, Football Teams, Counsellors and Trusts

#### Kenny Sanger (The Bunker)

Kenny has run The Bunker for over 20 years, and in that time, has also been a volunteer at Utopia FM, then assisting in the setup of Spark FM. He has led a team of volunteers from the local community to present and produce The Bunker show on Spark, in his role on the management team as Head of Local Music.

## Timetable for coverage roll-out

Sunderland Digital Radio aims to launch the multiplex within 6 to 8 months of the licence award subject to Ofcom approval of our final technical plan.

Funding will be available and Heads-of-Terms are sufficient to exceed the operating costs of the multiplex. We will continuing to actively pursue all expressions of interest and are confident to launch with a strong line-up of services.

Following the 'Guide to Launching' flowchart and the procedures set out in Ofcom's Technical Policy Guidance we aim to accelerate the implementation timetable by focusing on stages A to E.



#### Stages:

- A. In response to any technical mitigations in the award letter, we aim to finalise our site agreements and technical plan and submit to Ofcom within 10 weeks.
- B. On receipt of the hole punching document we will liaise with the national & local multiplex operators immediately. Responses received will be sent to Ofcom.
- C. Once the technical plan is signed off by Ofcom the equipment will be ordered and specifications shared with Ofcom. Installation date is scheduled and Ofcom is notified with twenty days' notice.
- D. Equipment is installed and commissioned.

As a leading small-scale DAB provider, Viamux will manage the implementation of the project. Availability of all equipment, software and professional services to meet our timescales are already confirmed.

We will be responsible for finalising site agreements and arranging broadband connectivity. A project GANTT chart (Appendix E) details the tasks, activities and timescales under which the implementation will be governed to achieve our target launch date.



The Bunker has been at the heart of the local Community for over 40 years, supporting local musicians and providing a base and space for people to develop their creativity, whilst contributing significantly to the North East region's cultural economy.

They engage hard to reach learners and run projects for people from minority groups or problematic backgrounds, to help people use music and radio towards a positive outcome.

The Bunker aims to build on the success of their own weekly radio show at Spark, by developing their own Digital Community Radio station to allow them to continue to promote local music, support local artists, raise awareness and tackle cultural barriers through interactive music projects, and continue to use music in helping improve physical or mental health and wellbeing of their Community.

# 5. Fair and effective competition

#### **Ethos**

Sunderland Digital Radio is conscious of its responsibility to ensure fair and effective competition, at all times. We believe that when competition works well, service providers are motivated to maximise audience share and are better able to secure funding on the basis of their service offering - its uniqueness, its audience and the value it delivers. Alongside established brands, competition delivers greater choice for listeners and a better outcome for the public. It also ensures the long-term sustainability of ser-vice providers. Our small-scale DAB platform will remain accessible to new entrants — a place where innovative formats will be encouraged and nurtured.

#### Leadership

An award of this licence to Sunderland Digital Radio Digital ensures that the multiplex is operated by locally led broadcasters and community members supported by experienced individuals who have successfully implemented and operate DAB multiplexes. All stakeholders are committed to small-scale DAB and have the financial stability to support that ambition. Our team is hugely experienced and well resourced, with significant practical broadcast radio expertise.

#### Delivery

Launching a small-scale DAB platform is a significant undertaking and we have been encouraged by the number of positive responses to our plans from local organisations. We have openly discussed our transmission plans, carriage terms and indicative fees. Sunderland Digital Radio has engaged with potential service providers in an open, non-exclusive manner and will continue to do so throughout the duration of this licence. Each service provider will enter into a Carriage Agreement - the key terms of which are identical for all service providers. A copy of the draft Carriage Agreement is provided as Appendix I. Fees charged are based on the capacity contracted by each service provider.

#### **Engagement**

We have taken and will take a number of steps to engage potential C-DSP and DSP broadcasters.

We have approached a number of existing broadcasters that have taken carriage on nearby SSDAB muxes (Newcastle and Gateshead, Tynemouth and South Shields, Darlington and Bishop Auckland) and broadcasters that we believe would benefit from taking carriage on our mux.

Our members have extensive contacts across the cultural and music scene in Sunderland; we have discussed our plans widely and have been encouraged by the interest shown. We have already generated significant interest from a number of diverse existing and new services, many of whom have signed Heads of Terms.

We have launched a dedicated company website <a href="https://sunderlanddigitalradio.org.uk">https://sunderlanddigitalradio.org.uk</a> which allows prospective customers and other interested parties to contact us. The website will be developed following a successful licence award. We will also launch social media accounts to promote the service and will include additional methods for prospective services to contact us.

Upon award of the licence we will publish a press release describing our intentions and encouraging services to contact us. We expect the press release will be published in industry media as well as local and regional publications.
