1. Overview

The purpose of this form

- 1.1 You should complete this form if you are applying for a licence to provide a small-scale radio multiplex service (a 'small-scale radio multiplex licence'). A small-scale radio multiplex service is the means by which DAB digital radio stations ('digital sound programme services') are broadcast, and can transmit around ten stereo digital sound programme services (or a significantly higher number if the DAB+ standard is utilised). The application form is divided into two parts Part A (which we will publish on our website) and Part B (which will be kept confidential). This document constitutes Part A; Part B of the application form is available separately.
- 1.2 Small-scale radio multiplex licences are awarded by Ofcom in a competitive process.

 Applications are judged against specified criteria, and Ofcom awards the licence to the applicant which it considers best meets the criteria.

- 1.3 There are detailed instructions on how to complete this form, and information on the next steps in the application process, in our <u>guidance notes</u> for licence applicants and licensees. Please read this guidance and the frequently asked questions carefully before completing this form.

The proposed Fermanagh small-scale DAB multiplex will deliver reliable indoor digital radio coverage across a substantial portion of central and southern County Fermanagh, using two transmission sites located at Rigg and Cloughtogle. Both sites will use new, non-directional antennas, mounted at between 14 and 16 metres above ground level, each transmitting at 100W ERP.

predicted indoor coverage, includes:

- Comprehensive coverage of Enniskillen, the main urban hub in the county
- Strong indoor signal in surrounding towns and communities such as:

The indoor footprint is expected to reach approximately 28,000–30,000 residents, providing robust signal access in homes and workplaces throughout the region.

Vehicular Coverage

Vehicular reception is expected to exceed the indoor coverage area, with consistent in-car reception along key routes such as:

- A4 (Enniskillen to Belfast)
- A32 (Enniskillen to Omagh)
- A509 (towards Derrylin and the Cavan border)

This extended reach will benefit commuters, logistics providers, and visitors exploring the Fermanagh Lakelands.


Terrain & Overspill Considerations

Despite the use of omnidirectional antennas, the mountainous terrain in the southwest of the polygon, particularly around Doon and Cuilcagh, provides a natural barrier to signal propagation beyond the intended area. This significantly reduces the potential for overspill into non-border regions of the Republic of Ireland, ensuring alignment with international spectrum coordination expectations. We also do not envisage any co-channel Interference to the area covered by the Newry Polygon which operates on the same frequency (and for which UlsterMUX is the current licence holder) from our proposed transmitter locations.

Even when combined with the existing coverage provided by the Newry multiplex, which we currently operate, the total coverage remains well below Ofcom's 40% population threshold. This clearly demonstrates our compliance with the spirit and letter of the small-scale DAB regulations, ensuring genuine localism rather than inadvertent regional overreach.

Financial and business plan

3.17 Please provide a high-level estimate of the costs you believe will be required to establish the multiplex service.

UlsterMUX - Financial and Business Plan

UlsterMUX, if successful in our application, will establish and operate the multiplex and transmission system entirely as an in-house project, with the exception of antenna rigging and electrical works, which will be contracted to qualified external specialists. This model enables substantial cost savings, as all directors have agreed not to charge for their time or services related to the multiplex or transmitter setup.

As a result, the majority of the setup cost is hardware-related only. In our previous (2022) Newry multiplex application, this approach resulted in a total setup cost of just over £25,000. While 2025 costs may vary slightly due to inflation or equipment availability, we do not expect a similar scale of expenditure, supported by internal expertise and the reuse of existing equipment assets where possible.

Equipment & Infrastructure

The technical requirements for this multiplex are modest. UlsterMUX already owns:

RF amplifiers suitable for the proposed ERP

DAB modulators compatible with the intended configuration

The only additional equipment required to bring the multiplex on air will be:

Critical mask filters

Band III DAB antennas

Hardware routers and EDI buffer mini-computers

MASK FILTERS - £1800

ANTENNAS - £400

MINI COMPUTERS - £200

These items represent a modest and manageable capital cost, and procurement has been scoped accordingly.

Transmission Sites

Broadcasting will utilise two existing Net1 NI Ltd core sites, where long-term access has been secured. Under the agreement with Net1 NI Ltd:

No site rental charges will be incurred by UlsterMUX for at least the first 4 years.

UlsterMUX will cover electricity costs only (approx. £1900 per annum)

This arrangement significantly reduces ongoing operational costs and integrates efficiently with existing ISP infrastructure.

Ongoing Operational Costs

Based on current agreements and forecasts, we anticipate annual running costs in the region of:

Site electricity (2 sites @ approx. £950 each/year)

Backhaul & IP connectivity

Ofcom regulatory fees

Insurance & contingency

Estimated annual total: £2900

All costs associated with this Ofcom application have already been funded and are not included in the above projections.

Funding Approach

UlsterMUX intends to fund the Fermanagh multiplex entirely through existing revenue streams, including:

Our successful SSDAB multiplex in Newry, operational since 2024

Outsourced multiplexing services provided to other SSDAB licensees across the UK

These activities generate sufficient income to cover both setup and first-year running costs without the need for external financing or director loans.

Commercial Model and Carriage Fees

We recognise that the population coverage of this proposed multiplex in Fermanagh is modest compared to urban areas and other areas of the UK. However, UlsterMUX believes this makes the case even stronger for an accessible and inclusive platform to support digital radio in areas which have been neglected up until now.

To that end, we will implement a community-first, low-barrier carriage model.

C-DSP Services

Free carriage will be offered to any C-DSP operator that establishes its base within the coverage polygon. The operator of Bounce Digital who is a director of Ulstermux will explore the setup of an Enniskillen CDSP similar to the operation currently available on the Newry multiplex

C-DSPs based elsewhere in Northern Ireland may join via DSP licensing, with reduced-rate DSP carriage available

Local DSP Services

Annual carriage fees of less than £1,000 will apply to local DSP services

This ensures affordability while contributing to core operational costs

We are also offering a very competitive rate for commercial FM and or National Stations to join for under £1500 per year

We have already received several expressions of interest from both C-DSP and DSP operators wishing to join the platform. We also have a high interest from licensed stations across the Irish border for whom at the time of this application, there is no defined avenue for them to become customers, despite the Media Bill having passed the lawmaking stage.

We believe it is vital for multiplex operators in Northern Ireland to have the ability to carry stations from the Republic of Ireland, reflecting the deep cultural, social, and economic ties across our shared island. Services such as RTÉ's Mini MUX and Raidió na Gaeltachta's availability on Freeview within Northern Ireland already show the importance and public demand for cross-border broadcasting.

Preventing multiplexes from carrying services from the Republic may risk breaching the spirit — and potentially the terms — of the Belfast/Good Friday Agreement, which recognises the importance of cross-community and cross-border cooperation. Furthermore, given the relatively low likelihood of stations from Great Britain seeking carriage in Northern Ireland, allowing Republic of Ireland services would substantially improve the chances of small-scale DAB success locally, enhancing both cultural diversity and economic viability.

Not-for-Profit Ethos and Reinvestment

UlsterMUX is a community-based, not-for-profit organisation. Any surplus generated will be reinvested into:

Hardware upgrades

Enhanced system resilience

Community outreach and education

VAT

The funding required to establish and operate the Fermanagh multiplex has been allocated and is managable UlsterMUX Ltd currently holds cash in company reserves, which is immediately available in our bank account and earmarked for this project upon licence issue.

In addition, UlsterMUX has recently completed contracted multiplexing operations for two other SSDAB licensees, with a third pending from a recent round 6 award which will more than generate the remaining funding requirements when complete. Discussions are also currently in progress with two additional SSDAB operators regarding provision of similar service agreements.

These income streams, together with existing reserves, will provide more than sufficient funds to cover both the setup costs (estimated at £2400) and year-one operational costs (estimated at £2900).

There are no pre-conditions or outstanding steps required to release any of this funding.

UlsterMUX is in a strong position to begin rollout quickly following licence award. The majority of the required equipment for this two-site multiplex is already available in-house, including RF amplifiers, modulators, routers, and associated hardware. The only outstanding items are Band III DAB antennas and critical mask filters, which have an estimated lead time of approximately five weeks from Italy.

We propose to place the final equipment orders upon approval of the technical plan. Subject to this approval, we anticipate an on-air date within two months, with full coverage as proposed achieved shortly thereafter. This schedule allows for equipment delivery, installation, and final system testing.

Uniform carriage agreements for all programme services to ensure consistency and fairness in our commercial dealings.

In addition, a 20% discount will be applied to any service that broadcasts at least 80% of its weekly content in either the Irish Language or Ulster Scots. This initiative is designed to support cultural and linguistic diversity and reflects the unique heritage of the region.

Ongoing Commitment to Fair Access
