Explanatory message for Notice under regulation 81 (Sent by Auctioneer: Mon 22 Mar 09:28) ▲

We have today sent you a Notice under regulation 81(1) of the Wireless Telegraphy (Licence Award) Regulations 2020 (the "Regulations") relating to a further deposit for the assignment stage round calculated in accordance with regulation 81(2).

Regulation 81(2) says that the required assignment stage deposit shall be an amount such that the total amount that the bidder has on deposit is not less than the amount which is the sum of —

- (a) the amount which is the bidder's total base price for its winning principal stage bids;
- (b) the amount which is the bidder's highest 700 MHz individual frequency lot assignment stage bid for a 700 MHz individual assignment stage option;
- (c) the amount which is the bidder's highest 700 MHz paired frequency lot assignment stage bid for a 700 MHz paired frequency assignment stage option; and
- (d) the amount which is the bidder's highest 3.6 GHz assignment stage bid for a 3.6 GHz assignment stage option.
